RE: Pulaski Community School District Oneida Language Program Request for Support

The Oneida Language, the language of the On^yote?a·ká· which is also known as the people of the standing stone has been a priority for the Oneida Nation and the Pulaski Community School District (PCSD). Over the past six school years, students have been exposed to this curriculum through both a classroom course and a lunchtime language group that focused on culture and language. This past year, the PCSD has continued to offer credit for the language levels of Oneida I, II, III and IV at the high school. With 146 Native American students in the PCSD, our current Title VI Native American Program initiative revolves around many of the language activities that are offered at Pulaski High School, Pulaski Community Middle School, and at Hillcrest Elementary School.

The PCSD will continue to provide students with innovative instruction while delivering the Oneida Language. This innovative instruction will continue to include the use of technology, technological applications, iPads, classroom blogs, one-on-one oral conversations, Elder Speakers, Oneida community resources, voice recording apps and other teaching methods including class participation, explaining, recitation, memorization, and collaboration. We are helping to create fluent speakers of the Oneida Language for years to come. These are high priority needs for the Oneida Nation. Innovative instruction and curriculum components in the Oneida Language classes will continue to be very successful if there is continued funding.

The current funds are used to provide instruction for the Oneida Language Courses (Oneida I, Oneida II, Oneida III and Oneida IV) at Pulaski High School, an Oneida Language Course offered at Pulaski Middle School, and an afternoon language program for students at Hillcrest Elementary School. This year the district has not been informed yet if we were awarded the American Indian Language Revitalization Grant. However, we do know that each year there has been a reduction in the American Indian Language Revitalization Grant from the Wisconsin Department of Public Instruction. This year the Oneida Tribe has supported and contributed to our substantial funding gap in our resources totaling \$54,000 for the 2019-2020 school year.

The creation and sustainability of language programs are very beneficial to Native American students, families and the community as a whole. Often times, when a student studies and learns another language, they begin to advance in their other academic areas. Exposure to another language can help to increase academic scores and grades for students enrolled in a world language course. Further, continued Oneida Language instruction is greatly needed within the PCSD to help provide the Native American students with a background in Native American

culture and identity. This class fosters students' sense of place and belonging in our ever-changing world, while strengthening their sense of identity. Through the use of research-based strategies and well developed curriculum based on language-acquisition, we will create well-rounded individuals that are culturally rooted in traditional values. The PCSD aims to sustain the Oneida Language Program. The program will continue to provide opportunities for our students to acquire, understand, speak, read, and write the Oneida Language, which supports the development of fluent speakers of the Oneida Language. By providing this language and cultural education in conjunction with our current graduation requirements, we are creating individuals that are prepared to succeed in the world.

Our supporting materials include: an infographic that outlines our programming, supports and funding; a brochure of our Native American Education Program for the Pulaski Community School District; we will include student testimonials through short videos that share the importance of the Oneida Language Programming for our students.

We would like to propose that the Oneida Nation and the PCSD continue to work in a collaborative effort to support the Oneida Language Programming with a renewable three year grant commitment. Within the renewable grant commitment, PCSD requests that the Oneida Nation financially support the full-time Oneida Language Teaching Position at \$54,000 with an annual increase of 3% CPI for salary/wage increase which will fund the shortfall between the cost of the position and current levels of Wisconsin Department of Public Instruction, Federal Title VI, and PCSD funding.





Oneida Language Revitalization Program Curriculum is based on <u>Language Acquisition</u>, with the *common goal* of <u>language functionality and fluency</u>, which focuses heavily on pronouns, stems, and word changes and therefore, provides a solid foundation that engages the student to connect and correctly identify how the language functions and how it is arranged


Our Staff provides:

- (1) direct assistance to local educational agencies and Department of the Interior/Bureau of Indian Education schools for the education of Indian children,
- (2) special programs, including demonstrations and the training of Indian individuals as educators, and
- (3) research, evaluation, data collection, technical assistance, and other national activities. The programs promote the efforts of schools, local educational agencies, and Indian tribes and organizations to meet the unique educational and culturally related academic needs of their American Indian and Alaska Native students." (Department of Education, 2017)

The purpose of the Native American Liaisons help ensure that the Native American students are well represented within PCSD.

Job duties include the following:

- Provide cultural enrichment for Native and Non-Native students, staff, and faculty.
- Provide culturally responsive mentoring for Native and Non-Native students, staff, and faculty.
- Provide culturally responsive academic enrichment and advising for students, and faculty.
- Focus on "Indian Education" which includes language, culture, and history of Indigenous peoples for both Native and Non-Native Students, staff, and faculty.
- · Promote a positive cultural identity and awareness.
- Encourage community outreach.
- College preparation.
- · Work to increase academic achievement.
- Assist with Title VI student certification.



American Education Program, strategically placed in the District to serve an optimal number of Native students.

Title VI - Native American Education Program Teacher (40 hours per week)

The Title VI Teacher serves in two capacities.

- Title VI teacher teaches math to students who need additional support.
- Title VI also emphasizes the importance of Native cultural learning. The Title VI teacher provides opportunities for Native students to learn and build on their understanding of and identity in their Native heritage. When possible, the teacher will provide school wide opportunities for cultural learning experiences.

Responsibilities and Duties:

- 1. Provide math assistance to all identified students
- Provide opportunities of cultural education for the Title VI students to learn and build on their understanding of and identity in their Native heritage
- 3. Learn and discuss stories and history to understand traditional values and world view
- 4. Understand the earth and environment through stories and ceremonies
- 5. Develop active listening skills on which other skills are built
- 6. Build unity through understanding stories, history, symbols, art, music and dance, and through social interaction
- 7. Provide after school program, weekly for Title VI students in grades 2-5
- 8. Assist with Title VI student certification
- 9. Parent and Teacher communication

Title: Oneida Language Teacher, K-12 of 74

Responsible for implementing, creating, teaching, delivering, and assessing the Oneida Language Program within the Pulaski Community School District to ensure a comprehensive education of the Oneida Language for students within the district.

Responsibilities and Duties:

- 1. Conduct research, gather data, and information about the status and state of the Oneida Language with the Oneida Nation of Wisconsin.
- 2. Create a grant application to be submitted to the Wisconsin Department of Public Instruction on an annual basis. Include research, data, and other relevant information for any necessary components of the application.
- 3. Assess student success, effectiveness, and retention data of the Oneida Language Program in the Pulaski Community School District.
- Complete trainings, workshops, and other annual indigenous language and/or educator conferences. Complete educator effectiveness requirements for licensure and the school district.
- 5. Create daily and weekly lesson plans and activities for each level of each Oneida Language class within PCSD.
- 6. Grade coursework in a timely manner and return to students with appropriate feedback.
- 7. Research new teaching and technology strategies and implement into language classes at the appropriate level.
- 8. Create course books and curriculum for each level of the Oneida Language Program including Oneida I, II, III, and IV and any other levels added in the future.
- 9. Meet the needs of all students and assist with their success in the program, which may include students from: multicultural and racial backgrounds, special education or students with IEP's, or other individual student needs.
- 10. Maintain a close working relationship with the Oneida Nation, Oneida community, Oneida Parents and families and the Oneida Language Revitalization program to further expand coursework, curriculum, fulfill grant requirements and incorporate feedback and suggestions into student learning objectives (daily, weekly, monthly, and annually).
- Maintain continued professional knowledge about the Oneida Language through personal classes in the afternoon each day with the Oneida Language Revitalization Program.
- 12. Maintain an organized and timely schedule for all classes taught each day within the district.
- 13. Provide an environment and opportunity for students to share ideas, provide feedback, and feel comfortable in learning their ancestral language and culture within a public school setting.
- 14. Responsibilities and duties are not limited to this list and can include additional components.
