Oneida confirms case of COVID-19

(Oneida Reservation) - Wednesday, April 1, the Oneida Nation has confirmed our first case of the Coronavirus within the Oneida jurisdiction. Though we cannot disclose details, we can share that all the appropriate measures have been taken to assure that the exposure risk is low at this point and the person has been isolated since the onset of symptoms. The process of notifying those individuals that the person was in close contact with has been done in accordance with Center for Disease Control (CDC) Guidelines, State of Wisconsin and Oneida Public Health Protocols. The confidentiality of the individual is protected by law. We

are assured the Oneida Health Center and local public health officials will continue to follow appropriate CDC and State recommendations to protect all employees and patients. The Oneida Nation is committed to protect our citizens, employees, patients, customers, and the general public during this difficult time. We want to reiterate that we need everyone to do their part in order to combat this pandemic. Please stay home, practice social distancing if you need to go out, wash hands frequently, and of course continue to support one another through sharing good words and prayer.

Symptoms of COVID-19

Reported illnesses have ranged from mild symptoms to severe illness and death for confirmed coronavirus disease 2019 (COVID-19) cases.

These symptoms may appear 2-14 days after exposure (based on the incubation period of MERS-CoV viruses).

The Oneida Nation is utilizing numerous resources to keep the community informed about the COVID-19 pandemic. This special edition of the Kalihwisaks is one of those responses to keeping people up to date with the ever-changing issue. This pandemic has really forced the Nation to become quicker in responding the concerns and as a result, the nation held their first ever question and answer update using Facebook Live as the format.

The 30-minute session was designed to give a quick update on the situation from Chairman Hill and also featured Dr. Vir from the Oneida Health Center along with Secretary Summers to support. The final portion of the session was guided by a live question and answer segment.

The final section presented more than 30 questions for the panel. Though not every question was answered in real time, most were. The questions that were not addressed

during the live event have been researched and those questions and answers were placed on the Oneida Nation Facebook page. With over 500 people watching live and over 7,000 views of the video following the conclusion, the demand is obviously there to do more of the live updates. More are planned for the future.

The Oneida Nation is committed to providing as much information to the community as possible during this unprecedented time. We have a special section on the Oneida Nation website, along with continuous work with a COVID-19 Communications Team who have set up a call center to answer non-healthcare related questions. TOBACCO LAW AMENDMENTS

The purpose of this law is to regulate the sale, possession and distribution of cigarettes within the Reservation.

The Tobacco law amendments will:

1. Define "tobacco products";
2. Clarify that cigarettes, electronic cigarettes, and tobacco products shall not be sold to any person under the age of twenty-one (21);
3. Clarify that no person other than an authorized employee shall sell cigarettes, electronic cigarettes, or tobacco products at an Oneida retail location;
4. Clarify that the process and procedure contained in the Nation's Citations law governs citations issued under this Law; and
5. Provide authority to the Oneida Business Committee to adopt through resolution a fine and penalty schedule for citations issued as a result of violations of this Law.

PUBLIC COMMENT PERIOD CLOSES THURSDAY, MAY 7, 2020

The Nation's COVID-19 Team issued a declaration on March 27, 2020, titled "*Suspension of Public Meetings under the Legislative Procedures Act*." This declaration provides that the Legislative Procedures Act's requirement to hold a public meeting during the public comment period is suspended due to the COVID-19 public health emergency. Although there will be no public meeting, the public comment period will still occur, and individuals can participate in the legislative process by submitting written comments, questions, or other input via e-mail to LOC@oneidation.org.

PROVIDING EFFECTIVE PUBLIC COMMENTS

Providing public comment is an important way to make your voice heard in decision making. Public comments can strengthen a decision or provide different perspectives. The Legislative Operating Committee wants to hear from you!



✓ READ THE PUBLIC MEETING MATERIALS: Before you provide comments familiarize yourself with the legislation. A public meeting packet is made for all proposed legislation and includes 1) a notice with the public comment period end date, 2) a draft of the proposed legislation, and 3) a plain language review of the legislation and its impact on the Oneida Nation.

✓ PREPARE YOUR COMMENTS: When you are familiar with the legislation, start to prepare comments. The LOC is responsible for reviewing every comment received. To get your message across effectively, frame your comment clearly and concisely. Here is an example of how to create an effective comment:

Least Effective Comment	More Effective Comment	Most Effective Comment
The Nation doesn't need a Tobacco law.	The penalties for violations of this Law are not strong enough.	Section 115.8-2 of this Law should be expanded to include other penalties in addition to citations, seizure, and disciplinary action.

- Not evict or terminate due to nonpayment of rent and/or utilities (rent payments are still due to prevent future eviction or termination)
- Postpone foreclosures currently in motion
- Not foreclose based on nonpayment of mortgage (mortgage payments are still due to prevent future foreclosure).

ferent options. We have loan deferrals for some of our customers, loan modifications, maybe suspending a couple of months of payments to help them get through, but we're encouraging all of our borrowers to contact us to see what their needs are and what would be best for them," she said.

We ask that those individuals that are not feeling well or if they are at higher risk, to stay home.

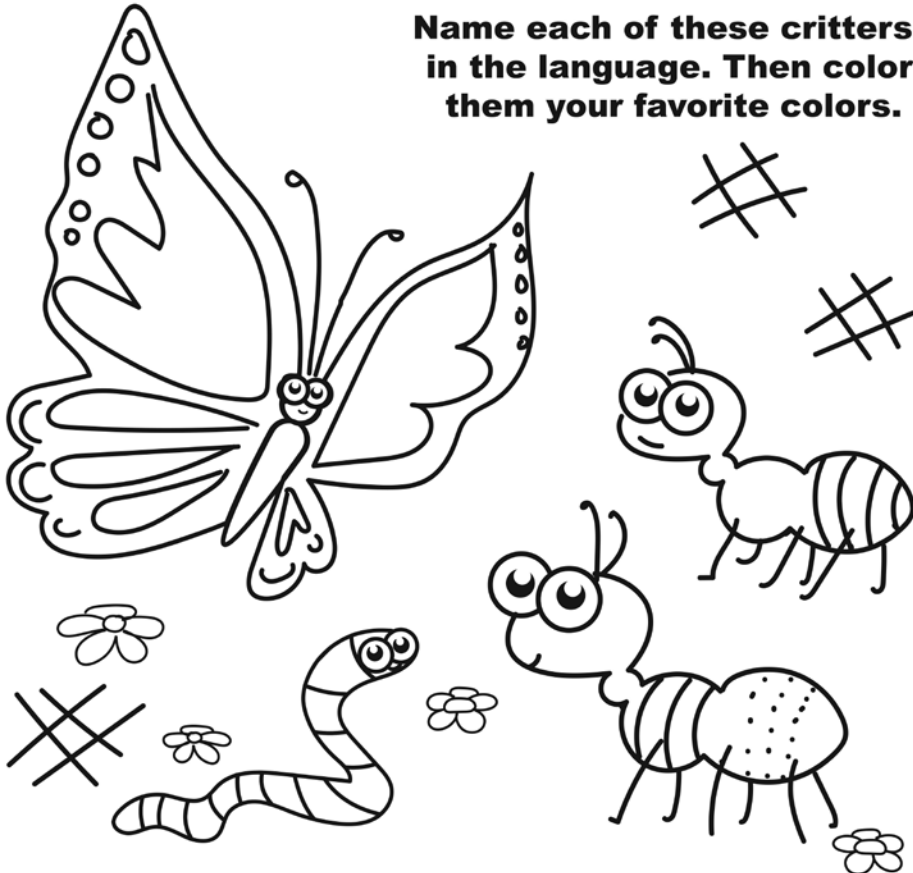

WHAT IS THIS ABOUT?

If you think you've been hurt by Purdue Pharma L.P., a U.S. limited partnership, its general partner and its subsidiaries, including Imbrium Therapeutics L.P., Adlon Therapeutics L.P., Greenfield BioVentures L.P., Avrio Health L.P., Rhodes Technologies, and Rhodes Pharmaceuticals L.P. ("Purdue"), or Purdue prescription opioids, like OxyContin®, or other prescription opioids produced, marketed or sold by Purdue, you can file a claim for compensation in the Purdue bankruptcy proceeding. The deadline to file a claim is **June 30, 2020, at 5:00 p.m. Eastern Time.**

WHAT IS A CLAIM AND WHO CAN FILE?

A "claim" means a right to seek payment or other compensation. You must file a Proof of Claim Form so it is actually received by the deadline. It can be filed by you, by a legal guardian, by survivors, or by relatives of people who have died or are disabled. **All Personal Injury Claimant Proof of Claim Forms and any supporting documentation submitted with those forms will be kept highly confidential and will not be made available to the public.** You do not need an attorney to file a proof of claim for you.

Additionally, partnerships, corporations, joint ventures, trusts, governmental units, and Native American Tribes may also file a proof of claim against Purdue. Go to **PurduePharmaClaims.com** to find a complete list of instructions on how to file a claim. You will also find a list of the opioids produced, marketed or sold by Purdue.

You may file a Proof of Claim even if a settlement is contemplated in the Purdue bankruptcy so that your claim can be considered as part of any settlement.

WHO DOES THIS AFFECT AND WHAT ARE MY RIGHTS?

If you think you've suffered harm from Purdue or its prescription opioids, you have the right to file a claim even if you may also have received reimbursement from insurance. Examples of claims that may be filed in the Purdue bankruptcy include death, addiction or dependence, lost wages, loss of spousal relationship benefit for things like child-rearing, enjoyment of life, etc., or Neonatal Abstinence Syndrome (sometimes referred to as "NAS"), among others.

The deadline to file a claim is June 30, 2020, at 5:00 p.m. Eastern Time. If you do not file a claim by the deadline, you will lose the right to file a claim against Purdue, and you will lose any right to seek payment or compensation you may have had. Proof of Claim Forms, a list of opioids produced, marketed or sold by "Purdue," and instructions for how to file a claim are online at **PurduePharmaClaims.com**.
