Vilas County man fined \$343.50, gets deferred prosecution for shooting at Native spear-fishers

James Alan Kelsey had Hate Crime modifiers dropped from his charges before he was handed a fine and a deferred prosecution agreement for shooting at Native American spear-fishers in May 2020.

A Vilas County man has received a fine of \$343.50 and given a deferred prosecution (DPA) disposition for shooting at several Native American spear-fishers on Little St. Germain Lake last spring. James Alan Kelsey, 62, of 1372 Tobin Lange Road in St. Germain, was originally charged with Operating a Firearm While Intoxicated and Disorderly Conduct with Hate Crime and Use of a Dangerous Weapon modifiers for the May 2, 2020, evening incident. The Disorderly Conduct charge, along

with the Hate Crime and Use of a Dangerous Weapon enhancers, were later dismissed by the prosecution. Kelsey was then found guilty by Judge Leon Stenz of a single misdemeanor count of Operating a Firearm While Intoxicated, which will be dismissed after one year if Kelsey successfully abides by the terms of his plea agreement.

Three Lac du Flambeau tribal members, two of them culture teachers, the other an elder combat veteran, were exercising treaty rights and harvesting walleye from a boat on the lake. Stephanie Stevens, from the Green Bay area, was invited along by her friends to observe. While they were on the boat, they heard someone shouting at them

from shore before hearing a loud gun shot. Responding Vilas County Deputies located Kelsey, who they say was shaky on his feet and slurring his speech which are indicators of alcohol consumption. According to local media reports, Kelsey claimed he was trying to shoot a red squirrel on the opposite side of his house from the lake. The deputies administered a preliminary breath test (PBT) on Kelsey which showed he blew a .204 blood alcohol content (BAC) at the time of the incident.

During a January 7, 2020, live public Zoom broadcast of Kelsey's plea and sentencing hearing from

the Vilas County Courthouse, three of Kelsey's four victims read victim impact statements, one through an attorney, to the court. Speaking on her own behalf, Stevens talked about how this incident has impacted both her and her family. "This incident has given me anxiety and was traumatic for me," Stevens told the court. "I'm not Native but I was looking to forward to relaxing with my friends on a boat while watching them practice the traditional art of spear-fishing. Instead. I became the victim of a hate crime."

Stevens spoke about what she saw that evening on the lake. "What I saw that night was James Kelsey's home," Stevens said. "All the lights were on in that house. I saw him notice our boat and I saw him get up and run outside, and then I heard someone yell, and then the shot. He had intent and he had anger. From now on I will have anxieties when I see silhouettes in homes and whenever I hear yelling

because I fear a gunshot will follow.

"James Kelsey was intoxicated with a firearm and supposedly shooting at a squirrel," Stevens continued. "I'm an avid hunter and every time I see a squirrel now I think about this incident. As I bow and squirrel hunted this year I watched them nest before the sun sets. Some nights we'll cover miles of ground and I've never once seen a squirrel out at night, not even when shining a flashlight into the of this case were unsuccessful, as trees. When I hear the shots of guns it reminds me of the shot that Kelsey took. This will affect James Kelsey for one year. This will affect us the entirety of our lives. A \$343 fine and one-year probation. This honestly feels like our lives have been equated to this \$343 fine."

Knowing Kelsey's legal record will be cleared of this incident after one year is upsetting to Stevens. "Hearing what James Kelsey will get off with is in itself another crime and an affront to what happened to me and

everybody else on that boat," Stevens told the court. "This serves as a statement that says it's okay to fire guns at marginalized people and women. After one year his record will be expunged. My PTSD won't disappear like his Hate Crime charge did. Nor will it with the message and the aftereffect that it can be open season on people like Natives and women."

Attempts to interview the victims were attempts to locate recorded versions of this live feed from the Vilas County Courthouse on various social media platforms.

While being placed into custody on the night of this incident, Kelsey allegedly told arresting deputies he didn't want to go to jail because, "I don't want to get the Covid, especially if the Indians are there."

GET THE FACTS: COVID-19 VACCINE



As of 1/08/2021

Q: When will the COVID-19 vaccine be available to everyone? How will I know it is my turn to receive the vaccine?

We believe every individual is a priority for vaccination and that every worker is essential to the community and their work is important. However, with the supply of vaccine expected to be limited initially, we will follow a strategic framework that is most impactful in dealing with this pandemic effectively.

COVID-19 vaccination in WI will occur in a phased approach. We are currently vaccinating persons identified by WI public health Phase 1a. This includes residents in long term care facilities and healthcare personnel. Because transitions from phase to phase will overlap, we are already preparing to vaccinate for the next phase; Phase 1b. We are currently awaiting additional information from WI public health of who will be included in the next phase. We anticipate this group will likely include persons 75 years and older and designated non-healthcare frontline workers of critical infrastructure such as public safety and education.

As we learn more, updates will be provided to the community through our social media pages, through Facebook Live and through FAQs offered to the community as we receive additional information. At this time, we do not have any timelines as it is based upon vaccine availability and the guidance of how to roll out the vaccine in phases.

Everyone that wants a COVID-19 vaccine will eventually get one. A vaccination distribution on this enormous level, worldwide, will take some time. In the meantime, it is critical we continue to practice COVID-19 safety measures as we have for the past several months; wear a mask, physically distancing, frequent hand hygiene.

What we understand right now for the phases:

- Phase 1a: Resident in long term care facilities and healthcare providers
- Phase 1b: Persons aged 75+ and critical infrastructure workers
- Phase 1c: Persons aged 65-74 and persons aged 16-64 with high-risk medical conditions

When people are eligible to receive a COVID-19 vaccine, notifications will be sent out to them with instructions on appointment scheduling and additional information.

Please do not call the Oneida Community Health Center to set up an appointment for COVID-19 vaccine - You will be notified when you can receive your vaccine. Everyone who wants a vaccine, will receive a vaccine once they are more widely available.

Q: When it is my turn to get the vaccine, where and how will I get it?

Health care staff continue to work on plans for future COVID-19 vaccine clinics for the community. The COVID-19 vaccine clinics may be similar to the annual Influenza clinics held at the Oneida Nation Elementary School. As more information is known, we will send out communications on the details of the vaccine clinics to the community.

Q: What type of COVID-19 vaccine will I get? Will it be the same type of vaccine everyone else gets?

The two vaccines that are currently authorized for use to prevent COVID-19 are the Pfizer-BioNTech COVID-19 Vaccine and the Moderna COVID-19 Vaccine. The Oneida Comprehensive Health Division received the Moderna vaccine in their first shipment, but could receive the Pfizer vaccine for the next shipment. Both vaccines have similar ingredients and possible side effects, they are just manufactured by a different company.

Q: Will I need 2 doses?

Yes, both the Pfizer and Moderna vaccines require a second shot 3-4 weeks after your first shot. When you receive your first shot, staff will setup your appointment to receive your second shot right away so you know when you have to return for your second dose. Staff are coordinating vaccine shipments to ensure people receive the same vaccine type (Pfizer or Moderna) for both doses.

Q: Are there side effects from getting the vaccine?

What have Oneida Comprehensive Health Division employees reported after getting their vaccine?

After you receive your COVID-19 vaccine, you may experience pain, swelling, and redness in your arm where you received the shot. You may also experience chills, tiredness, and a headache after getting your vaccine. These side effects usually start within a day or two of getting the vaccine but should go away in a few days. Oneida Comprehensive Health Division staff have most often reported having a sore arm where they received the shot.

Q: I already had COVID-19, is it safe for me to get the vaccine?

Yes, as long as you are out of your isolation period, you can receive the vaccine.

Q: What is the recommended timing with receiving other vaccines (i.e. Shingles vaccine)

At this time, it is recommended that you do not receive any other vaccine within 2 weeks of you receiving your COVID-19 vaccine.

Q:When I get my vaccine, can I stop wearing my mask and return to life as it was before COVID-19?

At this current time, no. The COVID-19 vaccine is an additional tool to help stop the spread of the disease, but it is important that we continue to use our other tools (masking, physical distancing, hand washing, etc.) for the time being.

Q: Can my child get the vaccine?

At this current time, the Moderna vaccine is only approved for use in people aged 18 years and older. The Pfizer-BioNTech vaccine is only approved for use in people aged 16 years and older. As more data is collected and analyzed, recommendations for vaccine eligibility may change to include children.

Q: Can pregnant and breastfeeding women get the COVID-19 vaccine?

It is strongly recommended that pregnant and nursing women be offered the COVID-19 vaccine. It should be a decision made after discussion with her provider. Counseling should include balancing available data on vaccine safety, risks to pregnant women from COVID-19, and individual risk factors for disease severity.

Oneida Nation receives \$44,170 grant for Youth **Agriculture Education**

The Oneida Nation has received a \$44,170 grant from the Native American Agricultural Fund. "NAAF is a private charitable trust that is the largest philanthropic entity in the United States whose purpose is to support the success of Native farmers and ranchers. NAAF was created as part of the settlement of the historic Keepseagle v. Vilsack litigation." The funds from this grant will support the efforts of the Oneida Nation to teach Oneida youth about sustainable farming practices including, watering source, soil remediation, traditional growing practices, planting, harvesting and food storage. The project will be a joint one between the Oneida Nation high school, the Falling Leaves 4-H, and OCIFS.

The grant will assist the Oneida Nation in creating a project that will emphasize the reintroduction of most of their traditionally important foods such as, beans, corn, and squash, as well as berries, fruits, and vegetables. The project will focus on the utilization of traditional Oneida food production methods. In addition to being economically and scientifically sound, that production method will have great social significance and will be focused on community production.

The crops to be produce will be farmed organically and with only natural soil remediation such as compost and animal waste techniques used. The crops will be grown with limited irrigation using only rain runoff and pond water. For this purpose, the pond which will serve as the main source of water on the site will be rejuvenated, supplied by local rains and renewed through the reintroduction of natural plants both in and



around the pond. Watering will focus cultural practices to our youth who on the use of drip hoses connected to a rainwater catching system installed on the roof of the barn. The pond and the drip line will both be replenished by using runoff from the barn watering system. When necessary we will draw water from the pond to water the crops.

The youth will learn about many traditional and sustainable practices such as the use and preservation of, soils, water, growing food, harvesting and storing food.



Oneida Community Members Important information for Drug or Alcohol Detox



OBH does have outpatient Alcohol and Drug treatment services. This includes same day assessments, individual sessions, intensive outpatient and aftercare groups. Currently these services are being offered through video sessions that clients can do from their home by smart phone or computer. OBH service providers can also facilitate residential or inpatient treatment for alcohol or drug use problems that meet a higher level of care.
