Business need: The Quality of Life Committee is standing committee of the Oneida Business Committee that will have oversight of health, wellness and social issues of the following areas of the Nation: Language, Culture, Health, Environmental Issues, Housing and Food Security and Sovereignty.

Objectives:

Business Objectives: The Quality of Life Committee will provide oversight developed in the Charter and provide recommendations of improvement.

Task Objectives: The Quality of Life Committee will meet on a monthly basis and review the items stated in the deliverables. Responsibilities outlined in the charter will provide a baseline in guiding team decision.

Deliverables: The following areas will deliver results related to quality of life

- A) Quality of Life Survey – Annually
- B) Readiness Survey from TAP – Monthly
- ~~C) Police Commission – Quarterly~~
- D) Oneida Native American Drug and Gang Initiative – Quarterly
- E) COVID-19 Report from Health Dept – Monthly
- F) Housing Needs of the Nation – Monthly
- G) HR Unemployment Rate – Monthly
- H) Environmental Issues – Monthly
- I) Wellness Council – Quarterly
- J) Live, Sustain, Grow – ~~Quarterly~~ **Annually**
- K) Food Security Update – Bi Monthly
- L) Recreation Integration - Quarterly

Team Structure:

- A) The Quality of Life committee shall be comprised of four (4) Oneida Business Committee members appointed by the BC. The remaining five (5) business committee members shall be ad hoc.
- B) Three (3) members shall make a quorum. A quorum is required at all meetings in order to be considered a formal meeting of the Quality of Life Committee.
- C) If necessary, an ad hoc member can fill in for a regular member in order to meet the quorum.
- D) All decisions made by majority vote.
- E) Direct reports along with appropriate staff shall be directed to attend the Quality of Life Committee meetings with relevant agenda topics.
- F) Chair of the committee will review agenda items prior to the meeting. Chair will also break any tie in voting. The Vice Chair will stand in for the Chair in the event the chair is unavailable.

Responsibilities and Rules

- A) The Quality of Life Committee is responsible for making policy recommendations to the Business Committee concerning areas outlined in the deliverables. The Business Committee will determine whether to accept the Quality of Life Committee's recommendations.
- B) Committee meetings will be held monthly with a prescribed agenda that will align with

one or all four of the current OBC strategic directions.

- *Advancing On^yote?aka principles

- *Committing to building a responsible nation

- *Creating a positive organizational culture

- *Implementing Good Governance process

- C) Coordinate all policy matters relating to the Quality of Life Committee in cooperation with any Department.
- D) Monitor activity and strategies with regards to areas of policy oversight assigned to this committee and align with strategic direction of the Business Committee
- E) Make recommendations to the Business Committee.
- F) Meeting may be held virtually with a quorum.

Process:

- A) Meetings shall be held on the 2nd 3rd Thursday of each month
- B) The ~~Quality of Life Chairperson~~ staff **BCSO** will prepare the meeting packets, minutes, recordings, and track all issues.
- C) A list of business unit representatives and boards/committee/commissions will be provided by direct reports.
- D) The Quality of Life Committee shall provide the OBC with the following per month: Meeting minutes, specific action items that may require OBC approval, quarterly reports.

Proclamation of the Rights of Nature

WHEREAS, as the Oneida Nation and its people proclaim the “Rights of Nature” on [February XX, 2021] because it is our responsibility for us to defend and speak for those things that cannot speak for themselves. Everything starts with our Creation Story. In it, our relationship and responsibilities are handed down from the Creator instructing us to be good stewards of creation. When we do, it is said the Creator provides everything we need within a specific balance.

WHEREAS, The Great Law and Thanksgiving Address are our guiding principles that give us instructions as we come together with one mind and to give thanks to the natural world. We must honor, respect, protect, nurture and caretake the very thing that sustain us. As Nature up holds its responsibilities, we must reciprocate our relationship back to her. As a way of life in the importance of our culture and original instructions, we teach our families through Respect, Reciprocity, Relationship and Responsibility with the natural world.

WHEREAS, our original instruction tells us we are born with the responsibilities and must acknowledge and take actions by only harvesting in sustainable ways by only taking what we need and giving thanks for allowing us to gather while replenishing this delicate balance of nature.

Oneida’s prophecies tell we must fulfill our responsibilities of the “rights of Nature” or we will not exist in the future. Chief Dan George is quoted: “If you talk to the animals, they will talk with you and you will know each other. If you do not talk to them, you will not know them, and what you do not know you will fear. What one fears, one destroys”.

WHEREAS, our past Environmental Policy of 1993 states the preservation and enhancement of our Mother Earth is an obligation of the members of the “Oneida Tribe of Indians of Wisconsin”. We give thanks for her wellbeing and all other forms which come from our Mother Earth. We the Oneida people cannot turn our backs on this responsibility of caretakers, the Oneida Nation has, from the beginning of time, co-existed with all living beings. The winged, the four—legged, all plant life, the trees, the stones, the water and the air. It is now time for the Oneida People to be held accountable to our children, their children, and for generations to come by creating a sustainable environment.

WHEREAS, our Live Sustain Grow Plan of 2008 establishes a framework for land use and protection programs. It addresses the importance of preservation, protection, and wisely manages the resources of the Reservation. We identified the need for improvement in resource management policies and procedures. We continue to solicit community input

on resource management decisions. This plan provides for acknowledging cultural needs of current and future tribal members.

WHEREAS, we will use the best available technology, employ best management practices and modern scientific methods to achieve this mission. The methods and principles used will be documented so they are defensible, **easy to replicate** and recognizable by the scientific community **while acknowledging the brilliance of our ancestors**.

WE RESOLVE that the Oneida Nation, its leaders, its people and government will use our sovereign freedoms to create and adopt legislative and judicial protection of the rights of nature utilizing good policies, science and culture.

WE FURTHER RESOLVE that we will work with other Tribes, State and Federal Governments, the United Nations and other Organization that has undertaken the Rights of Nature.

AND BE IT FURTHER RESOLVED that the Oneida Business enthusiastically endorses the “Rights of Nature” Proclamation and commits our government and its resources to engage in programs and activities to carry out each of our responsibilities to honor, respect, protect, nurture and caretaker the very things that sustain us.

BC Resolution # Support of Food Sovereignty and Food Sovereignty Policy

- WHEREAS,** the Oneida Nation is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Nation; and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1, of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS,** the Oneida Nation community, like other indigenous communities across the globe, has suffered a history of loss due to colonization and forced assimilation in the form of land loss, culture loss, identity loss, and indigenous diet loss; and
- WHEREAS,** due to these historical traumas that continues to be ~~to~~ intergenerationally inherited today, our indigenous populations see a disproportionately higher rate of physical, mental, emotional, social, and spiritual negative health impacts, including but not limited to: obesity, diabetes, cardiovascular disease, suicide, substance abuse, alcoholism, domestic violence, sexual abuse, discrimination, dehumanization, oppression and racism; and
- WHEREAS,** indigenous peoples continue to suffer negative health consequences as they attempt to navigate themselves in a society in which health equity continues to be a systematic problem that focuses on western society disease management and prescription medication and fails to acknowledge indigenous knowledge, which leads to the continuation of these negative health consequences. Today we acknowledge a balanced approach of western medicine and indigenous medicine which include medicinal plants, medicine societies, indigenous diet, and holistic health; and
- WHEREAS,** our original instructions, our worldview as On[^]yote? aka, connects us to the land, all of creation and ties us to the Kanehelat&hsla and the spirituality of farming, hunting, gathering, growing, harvesting, fishing, and agriculture that sustained us with our spiritual medicines, herbal medicines and foods that nourished our bodies, minds, emotions and spirits; and
- WHEREAS,** it is for these reasons, these original instructions have been embraced by our Tsyunhehkw[^] Agricultural operation, Oneida Nation Cannery, and OCIFS program since their inception, in which these operations have worked to transfer such knowledge of the value of sustainable agriculture and food sovereignty to our community and have championed such efforts for decades, being innovative leaders across Indian country; and
- WHEREAS,** since the control of indigenous food systems have been taken over by industrialized society, sovereign control of indigenous food systems are no longer promoted by western society; and
- WHEREAS,** according to the Declaration of Nyéléni made at the Forum on Food Sovereignty

in Sélingué, Mali, "food sovereignty is the right of peoples to healthy and culturally appropriate food produced through ecologically sound and sustainable methods, and their right to define their own food and agriculture systems"; and

WHEREAS, taking control over our own food systems and embracing Tsi niyukwaliho t[^] to build a culturally significant and sustainable sovereign local food system can prove to reconnect us with our land, culture, identity and spiritual wellness as Ukwehuwe, and indigenous diets; and

WHEREAS, by mending these historical losses, a sustainable food sovereignty initiative will serve to empower our people and community and work to combat these negative physical, mental, social, and spiritual health disparities, serving as a comprehensive strength-based approach to overall wellness in our community as well as a preventative intervention for our future generations by working to heal our minds, bodies, spirits, and emotions; and

WHEREAS, by empowering our community members in taking control of our local food system, we can strengthen our local economy while simultaneously addressing the systematic health inequities that exist in indigenous populations through the recognition that our food is our medicine.

NOW THEREFORE BE IT RESOLVED, that the Oneida Nation Business Committee does hereby support the food sovereignty initiative, including implementing the creation of Nation sponsored food sovereignty policy that includes and responds to the needs, commitment to Tsi niyukwaliho t[^], and creativity of our community members and established programs that provide and produce access to healthy foods for our people, thereby strengthening food sovereignty for us today and for future generations; and

BE IT FURTHER RESOLVED, this resolution is intended to support the leadership Tsyunhehkw[^], the Oneida Nation Cannery, and OCIFS has already shown in our food sovereignty efforts, **and to** make our food systems components accountable to each other and to the Nation, and strengthen this network; and

BE IT FINALLY RESOLVED, the intent of this resolution is to provide a model for how sustainable food sovereignty can be used to address and strengthen overall health and wellness within tribal nations; empowering and directing the organization under the General Manager of the Nation to prioritize, budget, and implement this model.

STATUS SUMMARY

TAP has been working with the Tribal Coordinating Committee (TCC) since December of 2020. These meetings are held every 2 weeks and we have been working on updating the goals of the TAP. At the last meeting which was held on Tuesday, January 5, 2021, the goals have been updated. The TCC started working on updated the objectives for these goals. The next meeting will be held on January 21, 2021 to continue working on those objectives.

TAP staff has been working with OBH and OPD on projects that Behavioral Health has pertaining to the COSSAP grant. Such projects are working on establishing a Rapid Response Team and the implementation of the Overdose Detection Mapping Application System (ODMAP) – Update: OPD completed a draft consent form, this needs to be further looked at. TAP has reached out to set up a meeting with the Kenosha County Task force to go over how they have their overdose system set up for referrals for those who have overdosed. We are waiting to hear back from Kenosha.

TAP has been working with Comprehensive Housing to work on the issue of housing complaints. TAP sat in on a meeting regarding the Public Peace Law on December 16, 2020. Clorissa Santiago who was the organizer of this meeting will be looking at the Residential Lease. The next Public Peace Law meeting will be held on Friday, January 15, 2021.

TAP has been working on the issue about Sharps being found throughout the community. Currently, we are working with OBH to see if we could contract with Vivent Health on a needle exchange program. Update: Mari K. with OBH is waiting for another meeting to be set up on this issue of space. Vivent Health needs us to have the space to set this program up.

The TAP specialist has been working on recording community members “recovery” stories. This will be an ongoing project and the first 2 recordings are in the editing stages. These videos will be posted on social media as well as the TAP website. Update: Leslie, the TAP Specialist worked with Michelle Anderson from Big Bear Media for more help with the editing.

On December 17, 2020, TAP was invited to sit in on the OBH Project Overview Presentation with OBH staff. TAP was able to meet the employees of OBH and see what each area is working on.

TAP has found 4 grants that will be looked at to see which one(s) we could possibly apply for. Renita will be looking these over and once we find one that is suitable for our needs, we will work with OBH and other departments to apply for those grants.

TAP met with Simone Ninham, Wellness Court Coordinator and Patty Hoeft, Trial Court Judge on December 29, 2020 to go over how TAP can help them to start organizing their plan for the wellness court. This initiative is also a part of goal 4 of the Tribal Action Plan. The updated goal is: Create a comprehensive Justice System that responds to alcohol and substance abuse. Simone will notify TAP when these meetings will start and to have TAP staff help facilitate the meetings.

TAP would like to start a community forum on Facebook regarding alcohol and substance abuse in the Oneida community. The Facebook post went out on January 6, 2021 to see if any community members would be interested. The purpose is to gain community insight and to educate community members of the current efforts.

Safe Care Pathway (SCP) / Suicide Screening

- Many of the OBH clinical sessions are now conducted virtually via MS Teams. All patients at OBH are screened for suicidal ideation at each meeting using the Columbia-Suicide Severity Rating Scale (C-SSRS).

Question Persuade Refer (QPR)

- QPR Trainings during 2020 – August completed QPR for all OBH non-clinical staff
- QPR OCHC – trainings on hold
- QPR & HRD Training Coordination – on hold

Safe Care Pathway (SCP)

- On 10-1-20 we developed a staff training plan to train each area and what their responsibilities and workflows will be in the SCP. This includes Triage, Nurses, Doctors, therapists, ATODA counselors, care managers, medical records, and other involved providers and supervisors.
- Completed annual risk assessment training for all OBH clinical staff during the months of July and August 2020. (July 28, 4 Triage staff; August 6, 13 Dual & NATODA staff; August 11, 3 Nurses; and August 12, 14 Mental Health staff).
