



## Wisconsin DOJ investigating officer-involved shooting

The Wisconsin Department of Justice (DOJ) Division of Criminal Investigation (DCI) is investigating an officer-involved shooting that took place in the Oneida Police Department parking lot during the early morning hours of Sunday, February 21, 2021.

Oneida Police Department dispatch requested a patrol officer return to the department headquarters at approximately 1:30 a.m. after a subject was witnessed driving his vehicle into the parking lot. The subject exited his vehicle and was acting erratically. When the responding officer arrived in the parking lot, the subject and the officer exchanged gun fire. The subject was hit and transported to an area hospital where he is being treated for serious injuries. The police officer was not hit and there were no other reported injuries.

The officer involved and the sub-

## Oneida Nation-Hobart Applefest litigation ends

(Oneida Reservation) – The Oneida Nation is pleased the Village of Hobart has decided not to seek review of the Big Applefest case by the United States Supreme Court. February 17 was the deadline for Hobart to file for a petition for certiorari with the Supreme Court.

Oneida Nation Chairman Tehassi Hill noted, "We now can close the books on this case and continue to exercise our sovereign jurisdiction

on our Reservation. We have always acted in the most prudent manner and regulated our affairs like a responsible government. In July 2020 the United States Supreme Court of Appeals for the Seventh Circuit issued a well-reasoned and definitive decision that our Reservation, established by the 1838 Treaty with the Oneida, remains intact. We recently observed the 183-year anniversary of the Treaty. The Village's deci-

sion not to prolong the case is good news and allows both governments to move forward without the cloud of litigation hanging over our heads. "We thank the United States, the State of Wisconsin, the National Congress of American Indians, the Indian Land Tenure Foundation and the Native American Rights Fund for their support in this case," Hill said

# Oneida's Tribal Action Plan continues to evolve

It's been several years since the Oneida Nation adopted its Tribal Action Plan (TAP) to combat the ever-growing opioid epidemic that has seized much of the United States. Since that time, current TAP leadership has been diligently updating the living document that reflects their current goals and objectives for the program. They've also brought the Tribal Coordinating Committee back into the fold that was part of the previous TAP program.

"In 2017 the Oneida Nation passed a resolution prioritizing alcohol and substance abuse prevention and treatment as a serious issue and developed this comprehensive strategy, in the form of a living and constantly evolving document, to help with the Anti-Drug Abuse Act of 1986," Renita Hernandez, TAP Manager, said. "The TAP utilizes the Tribal Coordinating Committee as its driving process to get information out and process information for developing programs."

The living TAP document is the set of goals and objectives used to help reach certain points in substance and alcohol abuse prevention. The goals of TAP are to raise awareness of the drug and alcohol epidemic in our community, as well as increase access to and raise awareness of the services offered relevant to alcohol and drugs. TAP personnel are developing a prevention and intervention strategy, as well as creating and implementing a comprehensive justice system that includes a wellness court and rehabilitative correction system. They are also looking into creating

healing spaces that accommodate the communities needs, including a sober gathering place and a transitional sober living facility, according to TAP Specialist Leslie Doxtator.

"The wellness court should be up and running by 2022," Doxtator said. "SOPs are being worked on and it will be used in conjunction with other local courts. This means that any Native American in Brown or Outagamie Counties that has a drug or alcohol conviction can choose to have their case heard here. It would be under our judiciary and they would be required to go through programming which could potentially reduce the charges against them."

"The Oneida Judiciary has said that when this program begins they may be able to handle maybe 10-15 cases," Doxtator said. "Hopefully this program will show the anticipated signs of success and we'll be able to handle more caseloads after that."

The continued need for the TAP program has been underscored by the fact that there was a reported 30 percent increase in area drug overdoses in 2020. "In our community we experience an overdose more frequently than we are aware of," Hernandez said. "From June through December of 2020 we gave out over 300 doses of Narcan. Behavioral Health distributes these along with training, and the last time around they ordered nearly 200."

The TAP program is also currently in the process of adopting an Overdose Detection Mapping System (OD Map) which captures the overdose reports in real time. "The Oneida Police Department (OPD) has been logging the overdoses that they encounter," Doxtator said. "This provides us with real-time information we didn't have previously because we had to go through Brown and Outagamie

Counties for that information. This new system will help because it's so difficult to get accurate statistics for just Native Americans and the fact that Oneida straddles two counties."

Additionally, TAP program personnel are currently working with Oneida Cultural Heritage to make their programming culturally significant for those seeking help. "We're really hoping to get the community more involved," Hernandez said. "Once COVID-19 is in the rear-view mirror we'd like to get more of our community involved in the various activities we participate in. We're also going to be looking for people who are in active recovery to share their story on video. We have a few who have already agreed and we are looking for more. ## OCIFS educational soil and water testing project set to begin

The Oneida Nation, in collaboration with the Native American Agricultural Find, will begin an educational project focused on soil and water testing and remediation and farming. The purpose of this project is to teach Oneida youth sustainable farming practices including, watering source, soil remediation, traditional growing practices, planting, harvesting and food storage. OCIFS will host a series of hands-on trainings for up to 15 youth ages 10 to 17 who are interested in farming, gardening, agriculture, and the environment. Participants

will be selected on a first come first served basis.

The crops to be produce will be farmed organically and with only natural soil remediation such as compost, animal waste and crop rotation techniques used. The crops will be grown with limited irrigation using only rain runoff and pond water. For this purpose, the pond on the site will be rejuvenated, supplied by local rains and renewed through the reintroduction of natural plants both in and around the pond.

Basketball has been played since the winter of 1891 when it was introduced by James Naismith. It has been widely known as a popular winter sport ever since.

But whoever thought that the sport would be impacted after 120 seasons by the Covid19 or coronavirus pandemic?

Last year's WIAA basketball season was cut short.

As strange as that was, this year's season has also been very different. While some M&O Conference teams have been playing since the season began in November, ONHS teams did not begin practices until after the first of the year.

It wasn't just a late start that made this season very different. At our first meeting we were told about the safety protocols -- masks, socially distancing and the rest -- that would be in place.

Still, ONHS basketballers were excited to finally be playing again, despite all of that.

Basketball was also impacted back during the 1918 Spanish Flu Pandemic in some of these very same ways.

they lit up his spirit. You would often find him mentoring or coaching them; playing with them; or turning them onto Gunsmoke and other old westerns. He often enjoyed a robust and marathon game of Uno with his kids; while listening to a variety of music, teasing, laughing, and talking about life and sports. He lived his life for his family and showed them the importance of being a family.

Pete's second love was sports. If he wasn't playing then he was coaching, mentoring, supporting young athletes or being a spectator. He often encouraged Oneida youth and you could typically find him, with a bag of popcorn, sitting on the benches at high school and summer league games cheering on whoever was playing. He was strong supporter of the North American Indigenous

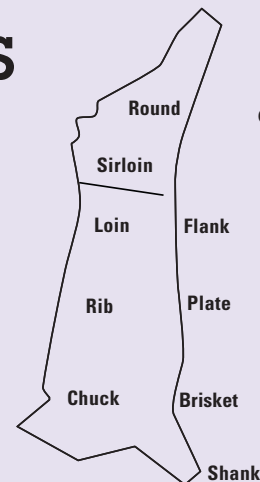
