# Hope in the fight against child abuse, neglect

The year-long pandemic has made daily struggles even more challenging, yet we've seen signs of hope in our community in the fight against child abuse and neglect.

Our agency is excited for this milestone: the first trial reunification for a family in an Oneida Family Court case. The children were removed from their home and placed with a relative while mom and dad worked on their challenges. After a year in which many of us also suffered losses of jobs, health and loved ones due to Covid-19, this young couple is now reunifying with their children so they can again live under the same roof.

"The whole family really put in the work," said Dakota Webster, the ICW case manager who worked with this family. "At first the mom told us, 'I just want to get my kids back.' Then she realized she needed to get herself healthy before she could be of help to anyone else."

Strong partnerships among community members, Family Service agencies, schools, and law enforcement agencies are essential in the fight against child abuse and neglect.

Our staff is wearing blue on Wednesdays in April to recognize Child Abuse and Neglect Prevention Month and will share family fun activities to encourage connection with the children in our lives.

Our Department is devoted to Healing Families Together and acknowledges that we all have the ability, and responsibility, to advocate for children and families.

"All children deserve to have healthy parents," Dakota said. Our department helps families identify and overcome the barriers and chal-

lenges they face, such as housing, Healing Families Together unemployment, transportation, and basic needs. The best defense to neglect and abuse is prevention, and a kisses and kind words safe, stable, and a nurturing environment. Education efforts pertaining to child maltreatment increase public awareness on ways to prevent and ily away from electronics recognize child abuse and neglect.

"I'm proud that we have our own Children's Code and are able as a tribe to be in control of what happens to our Native children. I am also appreciative of the resources that are available through our tribe. It's tough when you don't have resources available to help," Dakota said.

Of her recent case, she said the dad really turned around his life, too.

"They had to reinvent how they communicate as a couple, what they do as a couple and they had to fall in love all over again. It was really cool to see them come through," she said. The mom was already using coping skills when Covid hit and was able to put those skills into use, Dakota said.





The following proposed changes in the Rule Handbook are:

- Rule 4 Allowing for fuel/transportation assistance for applicants with local medical appointments;
- Rule 9 Increasing the amount of assistance for Medical Related Equipment, supplies, or Furniture;
- Rule 13 Increasing amount allowable for shelter assistance to align with other Rule amounts;
- Rule 14 Removing the requirement for funerals for out of state only, allowing for funeral assistance for in state as long as the funeral is more than 40 miles from current residence;
- Rule 16 Eliminate the restriction of Wisconsin being the only state for assistance, opening to any state within the United States. Eliminate repayment of program paid Security Deposit Assistance;
- Rule 17 Decrease Rent/Mortgage assistance to 12 months from 24 months.


