Radisson Hotel victims, shooter identified

(Oneida Reservation) – The gunman who shot and killed two people and injured a third before being fatally shot by responding law enforcement officers has been identified as 62-year-old Bruce Pofahl of the Green Bay area. Pofahl was a former Food and Beverage Manager of the Radisson Hotel & Conference Center's Duck Creek Kitchen and Bar Restaurant. Pofahl's employment was recently terminated from the restaurant and he was informed he was not to be on the Radisson Hotel property.

During a Monday morning press conference. Brown County Sheriff Todd Delain released more information about the incident that occurred early Saturday evening in the crowded hotel complex. According to Delain, Pofahl arrived at the Radisson Hotel around 7:30 p.m. while carrying a concealed 9 mm handgun. He then entered the Duck Creek Kitchen and Bar, walked to the waiter's station, and began firing. There may have been as many as 50 patrons in the restaurant at the time. It's not yet known if Pofahl specifically targeted his victims, but two employees, Jacob T. Bartel, 35, and Ian J. Simpson, 32, died at the scene.

Pofahl then left the restaurant and made his way outside the hotel on the north side of the complex where he then shot 28-year-old Daniel L. Mulligan, also a Duck Creek Kitchen and Bar employee. Almost immedi-

ately after Mulligan was shot a quick response team from the Green Bay Police Department ended the threat from Pofahl. Mulligan was airlifted to a hospital in the Milwaukee area where he remains in serious but stable condition.

Responding law enforcement agencies included the Green Bay Police Department, Oneida Police Department, Brown County Sheriff's Office, Hobart/Lawrence Police Department, and the Wisconsin State Patrol.

The officer-involved shooting aspect of this incident is being investigated by the Wisconsin Department of Justice's Division of Criminal Investigations (DCI), while the Brown County Sheriff's Department will be investigating the homicides and attempted homicide. The Federal Bureau of Investigation is also assisting with the investigations.

"We are extremely proud of the law

enforcement officers in our community running into this dangerous situation in the midst of chaos," Delain said. "These are difficult times for law enforcement. Our actions are often critiqued and second-guessed by those who cannot do our jobs. The officers in our community did not hesitate to respond in the time of need. They should be commended for their bravery in handling this tragic situation."

The Oneida Nation is offering counseling services to employees and any patrons impacted by this tragedy at the Irene Moore Activity Center (IMAC). Hours of service are 7-9 a.m., 12-2 p.m., and 5-7 p.m. No appointment is needed, and those interested are asked to enter through the employee entrance.

The DCI investigation into this incident will remain ongoing. This is a developing story and more information will be released as it is received.

Powless named new tribal General Manager

"It was always my dream to serve our Oneida community. Powless is looking forward to the new challenges his position will bring. "I'll be receiving much of my direction from the Oneida Business Committee and the General Tribal Council," Powless said. "As a result, I look forward to creating greater alignment with the mission of the Oneida Nation: 'To strengthen and protect our people, reclaim our land, and enhance

The Oneida One Stops in partnership with US Oil and Exxon Mobil rewarded 6 local schools with checks for \$500 each last week. The checks are part of the Education Alliance program and the funds were presented to Oneida High School, Oneida Middle School, Oneida Elementary School, Hillcrest Elementary School, Lombardi Middle School, and Green Bay Southwest.

The schools were nominated by Oneida Retail for the grant and each school was selected by Exxon Mobil. The grant is intended to help each school maintain/create science, technology, engineering and math (STEM) programs within the school.

Foster parents crucial to Oneida community

Two families who have more than 50 years combined experience as foster parents in Oneida know that the need for foster families is crucial for both kids and their birth parents.

Dean and Glory LaFlex, who have been foster parents for 25 years to dozens of kids, said their job is not to replace the moms and dads, but to provide a safe place until their parents get back on track.

"My heart goes out to them," said Glory. "How would I feel if I were taken out of my home? And for siblings, there's already enough trauma without having to separate them," she said.

As part of May's National Foster Care Month, Oneida's foster care program will host events aimed at recruiting new foster homes.

Vern and Lynn Doxtator, who have been fostering more than 25 years, opened their home to kids of all ages. In 2020, they received the Governor's Foster Care Awards for their service as a receiving home, and for short-term and long-term placements, respite care and adoption.

Reunification with birth parents is a priority, but the journey isn't always a straight line.

"Life can change at the drop of a dime. You've got to be able to roll with it," Vern said.

"All kids need structure," Lynn said. "They don't need a perfect parent, or someone who knows all the answers. They just need a safe place, and someone willing to try," she said.

Vern is an enrolled member of the Oneida Nation, and he and Lynn re-

main connected to the Oneida commudren return home. nity. They believe that the familiarity of the things that children experience on a day to day basis strengthens, rather than erases, the cultural identity of censing. Trauma informed parenting being an Oneida child.

Oneida's Children's Code is meant to protect Oneida children and strengthen tribal family life while recognizing that reunification with birth parents may not always be in the child's best interest. The Code also provides for transfer of Indian Child Welfare cases from state courts to Oneida Family Court when appropriate.

Nationwide, there are nearly a half million kids in the foster care system, and most of them have a court-ordered plan for reunification with their birth parents. About half of all foster chil-

Prospective foster parents need to pass a background check, and complete foster parent training and litraining is very helpful.

Dean and Glory have lived in the Oneida community for years. Dean, who is a Lac du Flambeau descendant, said Oneida feels like a big family.

"My heart is really here in Oneida,"

The LaFlexes try to attend to the spiritual, as well as physical, needs of kids. Dean is a licensed minister and is certified to teach the Fatherhood is Sacred, Motherhood is Sacred program.

Powless, Eugene Donald September 14, 1940 - April 23, 2021




Eugene Donald Powless passed away in California on April 23, 2021. He was living in Tuolumne in California. Eugene was the youngest son of Mark and Margaret

Oneida Community Integrated Food Systems (OCIFS) 2020-2021 School Year

This past year has indeed been a trying time for us all. With the start of the COVID-19 pandemic in early March of 2020, that caused most of the schools to go to remote learning. Although the schools were not holding in person learning for much of the year, there was still a need to feed our youth. For most of 2020 the kitchen staff at the Oneida Nation High School worked diligently to ensure our youth were provided a healthy, nutritious meal. Over the past year we served tens of thousands of meals out of the High School cafeteria. The people would drive up to the cafeteria, pick up the package of food and take it home.

The Oneida Nation schools have now started to provide limited classes in a classroom setting. The Elementary School and High School are at about 25% capacity for students. This means that the cafeteria staff provide breakfast and lunch to the students in attendance. Due to space limitations the students at the Elementary school eat in their classrooms, while the High School students can eat in the cafeteria (with social distancing strictly adhered to).

If nothing else, the COVID pandemic has shown light on the country's broken food system. More people are

now aware of where their food comes from and many of them are looking for locally sourced, nutritious foods. Although we are not yet where we want to be, Oneida has been ahead of the curve when it comes to serving local, nutritionally dense Oneida foods to our youth. The OCIFS members have been extremely helpful in making this happen.

They were instrumental in the transition to purchasing local products from our own orchard, and farms right here in Oneida. This is a great way to reduce transportation costs, travel distance, and increase the freshness of the produce we get from local growers. These efforts help us move in the direction of sustainability and food security and sovereignty for the Oneida Nation. We at OCIFS have been working hard to improve our network of suppliers so that we can provide the best quality foods for our students and community.

There was a time, not too long ago, when we at The Oneida Nation School System, purchased all red meat from our principle vendor Reinhart. We had no idea where this meat came from, or where it was processed. We would occasionally augment those purchases with Black Angus beef and Buffalo. Today I am happy to report that we

now purchase our red meats from Oneida Nation Farms, and occasionally augment our supply with purchases from Reinhart. Both Oneida Buffalo meat and Oneida Black Angus beef are served regularly in our school cafeterias in various recipes. We can order the beef to our specifications (90% lean) in the form that we use (mostly ground). These meats are processed within a small radius surrounding our schools, therefore they are considered local.

Hopefully in spring 2021 The Oneida Nation School System will be planning a larger school garden, improve usage of the green house at the Turtle school, and with a new resolve to increase the produce grown at the garden site. In cooperation with the Language and Culture departments, and the science department at the schools, we hope to provide enough fresh produce to serve in the school cafeterias throughout the school year. We would also like to bring seasonal products into the cafeterias for our students. These efforts will help teach our students the fundamentals of growing a garden at home and improve our sustainability for the next seven generations.
