# **Elder Assistance Program Law**

**Summary:** This request for a new law was brought forward by Councilman David P. Jordan based on a recommendation from the Chief Financial Officer during the October 20, 2021, LOC meeting. This request asks the LOC to consider developing a new law to establish an approved program under the Oneida General Welfare law which transitions the Nation's Elderly 65+ Per Capita Payment Distribution Fund, from being utilized for per capita payments to being utilized for general welfare assistance payments for elders.

- **<u>11/3/21 LOC:</u>** Motion by Marie Summers add the Elder Assistance Program law to the Active Files List with David Jordan as the sponsor; seconded by Jennifer Webster. Motion carried unanimously.
- 1/13/22: *Work Meeting*. Present: David P. Jordan, Jennifer Webster, Daniel Guzman King, Clorissa N. Santiago, Kristen Hooker, Carmen Vanlanen, Kristal Hill, Rhiannon Metoxen. #### **Title 10. General Welfare Exclusion - Chapter 1002 ONEIDA ELDER ASSISTANCE PROGRAM**

#### **1002.1.** Purpose and Policy 1

- 2 1002.1-1. Purpose. The purpose of this law is to establish the Oneida Elder Assistance Program
- 3 to govern how the Nation provides financial assistance to elders, pursuant to the principles of 4 General Welfare Exclusion.
- 5 1002.1-2. Policy. It is the policy of the Nation to prioritize the general welfare needs of its elders.
- 6 The Nation recognizes that its elders possess unique and irreplaceable stores of knowledge, skill,
- 7 culture, and experience that enhance and enrich the lives of every member of the Nation. The
- 8 interests of the Nation are advanced when its elders remain confident that their general welfare
- 9 needs can be met.
- 10

#### 11 1002.2. Adoption, Amendment, Repeal

- 1002.2-1. This law was adopted by the Oneida Business Committee by resolution BC- - -12 13
- 14 1002.2-2. This law may be amended or repealed by the Oneida Business Committee or the General
- Tribal Council pursuant to the procedures set out in the Legislative Procedures Act. 15
- 16 1002.2-3. Should a provision of this law or the application thereof to any person or circumstances
- 17 be held as invalid, such invalidity shall not affect other provisions of this law which are considered 18 to have legal force without the invalid portions.
- 19 1002.2-4. In the event of a conflict between a provision of this law and a provision of another law, 20 the provisions of this law shall control.
- 21 1002.2-5. This law is adopted under authority of the Constitution of the Oneida Nation.

- 23 1002.3. Definitions
- 24 1002.3-1. This section shall govern the definitions of words and phrases used within this law. All 25 words not defined herein shall be used in their ordinary and everyday sense.
- 26 (a) "Approved program" means any program(s) to provide general welfare assistance that 27 is intended to qualify as a General Welfare Exclusion, administered under specific 28 guidelines, and is adopted by the Oneida Business Committee through resolution or law of 29 the Nation in accordance with the Oneida General Welfare law.
- 30 (b) "Assistance" means benefits or payments under an approved program, which are paid to or on behalf of a recipient pursuant to this law. Assistance provided under an approved 31 program shall not be considered income of the recipient. 32
- 33 (c) "Lavish" or "Extravagant" shall have the meaning determined by the Oneida Business Committee in its discretion and based on the circumstances, taking into account needs 34 unique to the Nation as well as the social purpose being served by the particular assistance 35 36 at hand, except as otherwise may be required for compliance with final guidance issued under 26 U.S.C. §139E following consultation between the Nation and the federal 37 38 government.
- 39 (e) "Member" means an individual who is an enrolled member of the Nation.
- (f) "Nation" means the Oneida Nation. 40
- (g) "Recipient" means any member entitled to receive assistance in accordance with 41

- 42 approved program requirements.

#### 44 1002.4. Establishment

45 1002.4-1. Establishment. The Oneida Elder Assistance Program is hereby established as an 46 approved program of the Nation in accordance with the Oneida General Welfare law. The purpose 47 of the Oneida Elder Assistance Program is to provide financial assistance to elders of the Nation 48 to address the unique and compounding general welfare needs of elders.

49 General Welfare Exclusion. The Oneida Elder Assistance Program meets the 1002.4-2. 50 requirements of the General Test as defined in the Oneida General Welfare law; General Criteria as defined in I.R.S. Rev. Proc. 2014-35, section 5; and the requirements of the Tribal General 51 52 Welfare Exclusion Act of 2014, 26 U.S.C. §139E(b). The assistance provided through the Oneida

- 53 Elder Assistance Program is: 54
  - (a) paid on behalf of the Nation;
    - (b) pursuant to an approved program of the Nation;
    - (c) does not discriminate in favor of members of the governing body of the Nation;
  - (d) available to any eligible member of the Nation who meets the guidelines of the approved program;
- 59 (e) provided for the promotion of general welfare;
- 60 (f) not lavish or extravagant;
- (g) not compensation for services; and 61
- 62 (h) not a per capita payment.

#### 64 1002.5. Guidelines and Requirements

65 1002.5-1. Eligibility. The Oneida Elder Assistance Program shall be open to any individual who meets the following criteria: 66

- (a) is a member of the Nation;
  - (b) is age sixty-five (65) or older; and
- 69 (c) submits a completed application during the designated submission timeframe.
- 70 1002.5-2. Application for Funds. Any individual seeking assistance from the Oneida Elder 71 Assistance Program shall submit an application.
- (a) The Trust Enrollment Department shall make available an Oneida Elder Assistance 72 Program application form and instructions prior to July 1st of the year. 73
  - (1) The application shall require, at a minimum, the following information:
    - (A) first and last name;
    - (B) date of birth:
      - (C) street address, city, state, zip code;
    - (D) phone number;
    - (E) e-mail address;
    - (F) enrollment number;
    - (G) bank account information for direct deposit if necessary;
    - (H) description of need provided through options on the application and additional space provided therein;
- 84 (I) confirmation from the applicant that all information provided therein is
- 85 accurate and in accordance with the laws of the Nation and federal law; and 86 (J) signature of the applicant, electronic or handwritten, affirming the
- 87 attestation.

88	(2) On the application the applicant shall designate the means by which they would
89	like to receive their disbursement of funds from the Oneida Elder Assistance
90	Program, either through direct deposit or check.
91	(b) Applicants shall complete and return the Oneida Elder Assistance Program application
92	form to the Trust Enrollment Department by the close of business on or before September
93	1st in order to be eligible for assistance from the Oneida Elder Assistance Program.
94	(1) The information provided in the Oneida Elder Assistance Program application
95	form may be provided to any department, division, or personnel that processes the
96	applications.
97	1002.5-3. Disbursement of Funds. Assistance provided through the Oneida Elder Assistance
98	Program shall be disbursed on or before September 30 <sup>th</sup> of each year. Funds from the Oneida Elder
99	Assistance Program may be disbursed through direct deposit, or check, depending on the selection
100	made on the application by the recipient.
101	1002.5-4. Qualifying Expenditures. The following types of expenses shall be considered
102	qualifying expenditures for use of assistance from the Oneida Elder Assistance Program by the
103	recipient:
104	(a) costs relating to housing needs of principal residences such as:
105	(1) mortgage payments, rent payments, and down payments;
106	(2) enhancements for habitability of housing;
107	(3) basic housing repairs or rehabilitation;
108	(4) improvements to adapt housing for special health needs;
109	(b) costs for paying utility bills and charges, including, but not limited to, the following:
110	(1) water;
111	(2) electricity;
112	(3) gas;
113	(4) basic communication services such as:
114	(A) phone;
115	(B) internet; and
116	(C) cable;
117	(c) costs associated with food security;
118	(d) costs associated with home care assistance;
119	(e) costs associated with vehicle payments, maintenance, repair, and insurance;
120	(f) costs associated with medical care and transportation, room, and board costs for seeking
121	medical care;
122	(g) funeral and burial expenses and expenses for attending wakes, funerals, burials,
123	bereavements, and subsequent honoring events; and
124	(h) costs related to any other emergency circumstance.
125	1002.5-4. Oversight. The Trust Enrollment Department shall oversee the collection, review, and
126	permitted distribution of funds from the Oneida Elder Assistance Program to the qualifying
127	recipients.
128	1002.5-5. Records Maintenance. The Trust Enrollment Department shall be responsible for
129	maintenance of records for the Oneida Elder Assistance Program. The recipient shall retain
130	receipts for the expenditure of the funds associated with the Oneida Elder Assistance Program.

133 1002.6-1. Funding Source. The Oneida Elder Assistance Program shall be funded through the

- Emigrant NY Indian Claims Award Docket 75 Trust Fund and any other funding source deemednecessary by the Oneida Business Committee.
- 136 1002.6-2. Amount of Available Funding. The Oneida Trust Enrollment Committee shall
  137 determine the amount of assistance available to an eligible recipient from the Oneida Elder
- 138 Assistance Program per any permitted distribution.
