  WHEREAS the Oneida General Tribal Council is the duly recognized governing body of the Oneida Triba of Indian
- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Former Little Chief, LTD and Marina Solo New Construction, LLC Property
- WHEREAS, the parcel is described as follows: Legal Description: See attached.
