WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Tribe has determined as part of its Seventh Generation Commitment, "To develop a provisional system that fits our "family"/community values such as food, shelter, clothing and education as well as other services," and

WHEREAS, the Oneida Tribe has established the Oneida Nation School System for its most cherished responsibility—education of our children—to renew and revitalize the dignity of and harmony amongst Oneida People, in accordance with Oneida's need for cultural survival and well-being, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin continues to support the education of Oneida Nation youth by encouraging innovative teaching techniques that incorporate Oneida History and Culture, and

NOW, THEREFORE, BE IT RESOLVED, that the Oneida Tribe of Indians of Wisconsin submits a grant application to the Bureau of Indian Affairs for the "Language and Culture Grant" to support efforts ongoing efforts of training Language/Culture teachers within technology so that they can produce CD's of traditional songs and language in order to implement into daily lesson plans to better serve our students cultural needs.
