
Wisconsin ADA Partnership Mini-Grant Oneida Elderly Program

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin has determined that the overall goal of the Oneida Nation is to protect, maintain and improve the standard of living and the environment in which the Oneida people live, and
- WHEREAS,** the Oneida Tribe understands the need to improve and enhance the memberships self-sufficiency by providing resource capabilities, as well as those specifically for the elders with disabilities, and
- WHEREAS,** the Oneida Tribe has developed the Oneida Elderly Services Program to assist our elders to maintain and independent, healthy, productive and quality lifestyle, through love, caring and respect by the services we provide, and
- WHEREAS,** the Wisconsin ADA Partnership has monies available for mini-grants to provide funding for small projects to assist in a variety of areas for those with disabilities.

NOW, THEREFORE, BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin hereby submit this application to the Wisconsin ADA Partnership Mini-Grant Program for the purpose of assisting in the efforts of providing for safe, affordable, and accessible transportation for Oneida Elders with disabilities.
