RESOLUTION # 1-22-03-A
RESOLUTION RESCINDING AND REPLACING RESOLUTION # 9-04-02-B
(LAND CLAIM NEGOTIATION TEAM)

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Tribe and a Treaty Tribe recognized by the laws of the United States of America; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Constitution by the Oneida General Tribal Council; and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is engaged in negotiations with the State of New York to settle the Oneida Land Claim; and
- WHEREAS,** the Chief Negotiators have been the primary representatives of the Oneida Tribe of Indians of Wisconsin in the aforementioned negotiations; and
- WHEREAS,** the Oneida Business Committee, by Resolution # 9-04-02-B, designated the Chairperson, the Vice Chairperson, one Council Member, the General Manager, and one Land Claims Commissioner as the Chief Negotiators; and
- WHEREAS,** the Oneida Business Committee recognizes the necessity for continuity and timely progression for the Land Claim negotiations;
- WHEREAS,** the Oneida Business Committee recognizes the importance of having information brought forward in a timely manner as soon as the public disclosure of such information will not compromise ongoing litigation or negotiations; and
- WHEREAS,** the Oneida Business Committee desires to designate Chief Negotiators from among its own membership.


NOW, THEREFORE, **BE IT RESOLVED**, that Resolution # 9-04-02-B be and hereby is rescinded; and

BE IT FURTHER RESOLVED, that the Chairwoman, the Vice Chairwoman, and one Council Member shall serve as Chief Negotiators for the Oneida Tribe of Indians of Wisconsin in the Land Claim settlement negotiations; and

BE IT FINALLY RESOLVED, that the Chief Negotiators are hereby directed to present final recommendations for settlement of the Oneida Land Claim to the Oneida Business Committee by July of 2003.
