Resolution in Support of Councilman Paul Ninham's Appointment to the Board of Regents for Haskell Indian Nations University

- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida General Tribal Council has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution, and
- WHEREAS, the Oneida Business Committee has been delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe of Indians of Wisconsin recognizes and supports Haskell Indian Nations University in its purpose to provide baccalaureate degrees to American Indian students and its goal to become a national center for Indian education, research and cultural programs; and
- WHEREAS, over the past ten years, Thelma McLester, an Oneida Tribal member and employee of the Tribe, has served as a Board of Regents member and is now resigning from this position; and
- WHEREAS, it is important to provide continued support for Haskell Indian Nations University and to also ensure that tribal representation on the Board of Regents continues; and
- WHEREAS, the Oneida Business Committee believes that Councilman Paul Ninham would be an excellent representative of the Tribe on the Board of Regents.

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee does hereby officially support the appointment of Councilman Paul Ninham to the Board of Regents for Haskell Indian Nations University.

NOW THEREFORE BE IT FINALLY RESOLVED, that this resolution be delivered to the next meeting of the Haskell Indian Nations University Board of Regents and that copies be provided to the President of the University, Karen Swisher and the Chair of the Board, Judy Dehose.
