RESOLUTION #12-31-03-D REGARDING PARDON OF SCOTT D DOXTATER

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV., Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Pardon Screening Committee has presented a Pardon Petition on behalf of <u>SCOTT D DOXTATER</u>, and

WHEREAS, the requirements of the Oneida Pardon Ordinance have been fulfilled, and

WHEREAS, the Oneida Pardon Screening Committee hereby recommends <u>GRANTING</u> the pardon petition of <u>SCOTT D DOXTATER</u>, Petitioner.

NOW THEREFORE BE IT RESOLVED, The Oneida Business Committee by this resolution hereby:

GRANTS the Pardon of SCOTT D DOXTATER, Petitioner, for Obstructing an Officer conviction of 04-16-96, Criminal Damage to Property conviction of 04-16-96 and Issuing Worthless Check conviction of 04-18-97; and further notifies the Oneida Nation and its employing agencies that the Petitioner is recognized as a member of the Oneida Nation to have all the benefits and employments opportunities available to all other persons as if the criminal past pardoned by this Resolution did not exist. This pardon is granted by the signature of all members of the Oneida Business Committee members on the attached Pardon Certificate.

CERTIFICATION
