SUBJ: 2022 SPECIAL ELECTION APPLICATION PERIOD

On January 12, 2022, BC Resolution 01-12-22-B Extension of Declaration of Public Health State of Emergency Until March 24, 2022, was adopted. The Election Board has requested that there not be a 2022 Special Election Caucus since it is still advised for the membership to stay home and to social distance, it was decided it would be in everyone's best interest to cancel the caucus.

This is a notice of the 2022 Special Election and how the membership will be able to apply for their name to be placed on the ballot. Applicants may pick-up and drop-off application materials in the main office of Norbert Hill Center during normal business hours the week of April 25th – May 6th (8:00 a.m. – 4:30 p.m.). Mailed, faxed, or e-mailed applications will not be accepted.

All individuals applying for their name to be placed on the 2022 Special Election ballot will need to complete a separate application for each position vying for. Beginning April 25, 2022, applications may be picked up in the main office of the Norbert Hill Center or you may find an electronic fillable version of the application on the Nations website by going to www.oneidanation-nsn.gov under Government/Forms & Applications. The deadline for all application forms and referendum questions to be submitted to the Business Committee Support Office:

FRIDAY – MAY 6, 2022, BY 4:30 P.M.
