Approval of Use of Economic Development, Diversification and Community Development Funds for a Capital Contribution of \$750,000 to the Oneida Airport Hotel Corporation Project Number ED22-003

WHEREAS,	the Oneida Nation is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America; and
WHEREAS,	the Oneida General Tribal Council is the governing body of the Oneida Nation; and
WHEREAS,	the Oneida Business Committee has been delegated the authority of Article IV, Section 1, of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
WHEREAS,	the Economic Development, Diversification and Community Development Fund was created by resolutions # BC-09-28-16-B, BC-07-12-17-A, and BC-01-23-19-D and the procedures for use of the fund set forth in resolution # BC-12-12-18-B, BC-01-23-19-C, and BC-05-26-21-B, <i>Updating and Clarifying Access to the Economic Development, Diversification and Community Development Fund As Amended</i> ; and
WHEREAS,	the Oneida Nation has created chartered corporations for the economic development and diversification of the Oneida Nation's economic well-being, and
WHEREAS,	the Oneida Nation has chartered the Oneida Airport Hotel Corporation in 1984, and
WHEREAS,	the Oneida Business Committee has received a request from the Oneida Airport Hotel Corporation (OAHC) for a capital contribution of \$750,000 which will allow OAHC to remove existing asphalt, grade it and put down new asphalt pavement and remove and replace sidewalks that are severely in need of replacement and are now a liability; and
WHEREAS,	the Oneida Business Committee has directed the Economic Development, Diversification

and Community Development team to review and recommend the use of \$750,000 for a capital contribution to the OAHC; and

WHEREAS, utilizing the Economic Development, Diversification and Community Development Fund to provide the asphalt and sidewalk renovations is aligned with the Oneida Business Committee Broad Goals, the approved Comprehensive Plan Elements related to economic development, and the approved Economic Development Plan.
