WHEREAS,	the Economic Development, Diversification and Community Development Fund was created by resolutions # BC-09-28-16-B, BC-07-12-17-A, and BC-01-23-19-D and the procedures for use of the fund set forth in resolution # BC-12-12-18-B, BC-01-23-19-C, and BC-05-26-21-B, <i>Updating and Clarifying Access to the Economic Development, Diversification and Community Development Fund As Amended</i> ; and
WHEREAS,	the Oneida Community Lacrosse Program is a non-profit, community-based program, whose goal is to engage the youth in our community in a positive environment through lacrosse; and
WHEREAS,	the Oneida Community Lacrosse Program is associated with Oneida Youth Leadership Institute (OYLI) Fund; and
WHEREAS,	the OYLI is by the authority of the Oneida Nation, the Board was established by the Oneida Youth Leadership Institute's Charter, which was adopted by Oneida Business Committee resolution #09-14-16-B; and
WHEREAS,	the official mailing address of the board is P.O. Box 365, Oneida, WI 54155; and
WHEREAS,	the Oneida Community Lacrosse Program has fundraised and used other grant partnerships and raised at total of \$9,999 for their current equipment; and
WHEREAS,	the Oneida Community Lacrosse Program is requesting additional funding for the program's unmet equipment needs and a trailer for the transportation and storage for all
