## INSTRUCTIONS FOR ISSUING A SUBPOENA (See Title 8 O.C. Chapter 803.24)

- 1. Provide the Clerk with the name and address of the witness you wish to subpoena.
  - a. An attorney, admitted to practice in the Oneida Judiciary, may also issue and sign a subpoena as an officer of the Court.
- 2. The Clerk will issue you a subpoena.
  - a. Confirm that all the information has been completed on the subpoena.
- 3. Serve the subpoena on the witness (and other parties, if required by section 3.a.i. of these instructions).
  - a. Serving a subpoena requires delivering a copy to the named person. Service may be made by any person who is at least 18 years old, including a law enforcement officer, and not a party to the case. You may not deliver the subpoena yourself!
    - i. If the subpoena commands the production of documents, electronically stored information, or tangible things or the inspection of premises before trial, then a copy of the subpoena shall also be served on the other party or parties to the case.
  - b. The person serving the subpoena must complete an Affidavit of Service which is included in this packet. The Affidavit of Service must be filed with the Clerk's office after service upon the witness (and other parties, if required).
    - i. The witness (and other parties, if required) may waive service by completing an Admission of Service, which is also included in this packet.
      - 1. BE SURE THE WITNESS (AND OTHER PARTIES, IF REQUIRED) SIGNS THE ADMISSION OF SERVICE IN FRONT OF A NOTARY PUBLIC SO THAT THE SIGNATURE IS NOTARIZED.
