**Oneida Farm Devastated by Storm**

Several tornadoes touched down in Wisconsin on Wednesday, June 15, 2022 resulting in damages to many Oneida homes and structures, including the Oneida Nation Farm (ONF). ONF sustained heavy damage from up to 100 mile per hour winds. This is in addition to the previous heartbreak ONF experienced just two months prior, when a fire destroyed two hay sheds.

Multiple farm buildings, including the largest primary feeding silo, which once stood 80 feet, is now at 40 feet. As a farm employee explained, “The top of the primary feeding silo had been

blown off and fell into the feeding room below.” The feeding room, connected by a conveyor system

**Herb Lewis donates WPA work papers to Oneida**

The year is 1998 and Herbert Lewis, now an emeritus professor of Anthropology from the University of Wisconsin – Madison, was approached by a secretary carrying a large box of letters from a former professor who died in 1947. Lewis began reading these letters and noticed the name Floyd Lounsbury, well known for his studies in linguistics and Native American languages. Intrigued, Lewis inquired more about this box of letters and in so doing, was told by a colleague to look for another large box in the storage room labeled “Oneida”.

Within this box, Lewis found 165 sonographer notebooks filled with Oneida biographies from people of all ages, where they talk about social criticism and their general thoughts of life. This is the Oneida Linguistic Project that had been forgotten for 60 years.

As Lewis continued his research, he discovered that the Works Progress Administration hired Morris Swadesh, a local linguist, to study a Wisconsin Indian language that was struggling. Swadesh, in 1938, identified the Oneida language as a good candidate and thus, decided to hire bilingual Oneidas, many of which were already

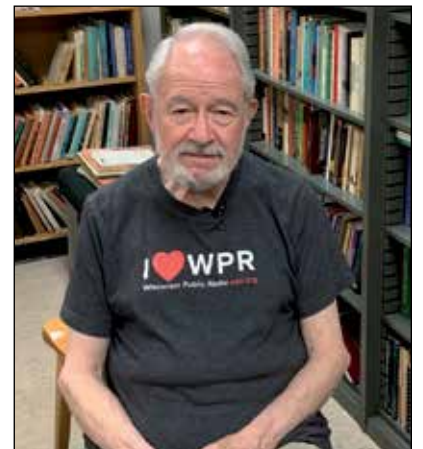

that extracts feed from the silos, is totally inoperable. According to ONF staff, the damage is not enabling them to provide the normal feed mixture, forcing them to make alternative measures to maintain the cattle's diet.

Also, the barn that shelters the herd has multiple missing panels along the sides and roof. On the east side of the building, the connected straw and waste storage area has support beams that are literally twisted. Additionally, part of the roof of a hay shed on the south side of the property had also been blown off. The grain bin facilities area sustained an estimated damage of \$200,000.

Oneida Nation Farm is estimating \$500,000 in damages. However, that number could continue to grow as there might be a backup in contractor availability that could cause long wait times for repairs. On the bright side, the storm caused no injuries or deaths to any staff or livestock.

Tens of thousands of families in Northeast Wisconsin were without power as a result of the June 15 storm, some from Wednesday until late Sunday afternoon. Without electricity or generators, many Oneida members lost their valuable frozen or refrigerated food supplies.

Thankfully, like many other small communities, Oneida is made of people who care very deeply about the welfare of their neighbors, friends and relatives. During the roar of chainsaws and trucks clearing storm damage, Marlon Skenandore, Food Pantry Director, was quietly personifying their vision, “An engaged community that alleviates emergency hunger together.”

Skenandore, with the help from the Feeding Wisconsin organization and local grocery stores, charged ahead to provide relief to families hit hardest with food loss. A few phone calls resulted in six pallets of produce, along with frozen chicken provided by Festival Foods. When asked about the frozen chicken supply, Skenandore explained that in this instance, the chicken

couldn't be sold as retail because it was inadvertently frozen instead of refrigerated. Nevertheless, it was still perfectly fine to consume.

Skenandore, his staff, and volunteers, began distributing emergency food supplies at noon, Monday, June 20. The entire crew came together to answer the call for anyone who came through their door, which Marlon praised by stating, “None of this work is possible without the volunteers that sustain our operations and distributions to the community.” Ironically, Skenandore's leadership, along with his team, created their own “Perfect Storm” to help those affected by the storms of June 15. Bravo!

### Rational of cancellation of June 21, 2022 GTC meeting

The safety of the Oneida Membership is top priority when deciding whether or not to proceed with in-person GTC meetings. The Centers for Disease Control (CDC) has provided guidance throughout the pandemic; current CDC guidance focuses on COVID-19 Community Levels which measure the impact of COVID-19 in terms of hospitalizations/healthcare system strain (lagging indicator) and transmission/new cases in the community (leading indicator). This guidance assists communities and public health officials by utilizing low, medium, and high thresholds - <https://tinyurl.com/ComLevel>. For the June 21 GTC meeting, we assessed 1 week before and COVID-19 Community Levels were at HIGH in Brown County and MEDIUM in Outagamie County. Since that time, thankfully, the levels have dropped to LOW in both counties. We will continue to monitor as we proceed towards the July 19 GTC meeting. We're hopeful that we will be able to proceed. Regarding virtual GTC meetings, the BC has developed a proposal that we plan to present to GTC during the semi-annual meeting. Until then, we wish you good health and happiness.

working for the WPA, and thus, were better utilized for this project.

Over the next year and a half, these Oneidas interviewed their neighbors and relatives regarding their own stories. Many of these stories included jokes, recipes, and traditions. Lewis would go on to say how this material would become part of the Oneida dictionary and on a more personal level, how impactful this study was on his perspective.

In Lewis' book, *Oneida Lives*, it states, "The Oneida WPA writings illustrate this: the men and women who speak through these narratives opened up and told the world about their lives and their feelings. Together they give us a portrait of a group of individuals with a variety of different personalities and different experiences who have retained a distinctive and well recognized identity and social and

cultural patterns of their own. They offer an excellent example of a people who had undergone massive change in acculturation over several hundred years...Who share the majority of their culture with their non-indian neighbors, but nevertheless remain distinctively themselves. Indeed, this seems equally true of the Oneidas today more than 60 years later."

Lewis also said, "I would be reading in my office, these accounts, I've read every page, and every day I would find something, and I would pick up the phone and I would call my wife and I would say: you just gotta hear this... These excerpts are just so full of life and meaning. It's my hope more people will read this, not only Oneidas but all people to see what life was like and how people came through from the depths of poverty."

# Emergency Management Preliminary Report of Wednesday, June 15, 2022.

On Wednesday, June 15, 2022 the Oneida Nation and the surrounding communities were impacted by an F1 Tornado that touched down near Seymour. Many areas of the Reservation were impacted with downed trees which fell on powerlines causing wide-spread power outages.

Emergency Management (EM) virtually activated the Emergency Operation Center (EOC) on Wednesday evening before the storm entered the area. As information was provided to EM detailing the amount of damage it was apparent that EM would need to coordinate with several different departments of the Nation that are designated as Emergency Response areas to provide resources and assistance to the community.

When the Nation is impacted by an emergency or disaster it is

the responsibility of the office of Emergency Managements to provide any unmet resource needs to the areas or departments of the Nation that are designated as responding entities.

EM coordinates resources and reaches out to other entities to find additional resources that our departments can't fill when the response is beyond their capabilities.

EM worked with the Oneida Business Committee, the Oneida Police Department, Communications, Department of Public Works, Conservation, the Emergency Food Pantry, Housing, Aging and Disability Services, the Oneida Comprehensive Health Division, and the Governmental Services Division to address the needs of the community. On Thursday morning these teams were able to make assessments to close the operations of the Nation due to the amount of damage that impacted the reservation.

EM coordinated the resources necessary to provide food, water, shelter and charging stations for electronics throughout the day. Additional resources for clean-up and dumping were also available.

Clean-up continues to occur across the reservation. Conservation has had extended hours for people to get rid of their wood debris. The forestry and conservation departments continue addresses requests for tree removal on personal properties.

The Oneida Emergency Management and all Tribal Departments appreciate the spirit of the Oneida Community who reached out to volunteer and help one another. A more detailed report is being completed and will be shared.

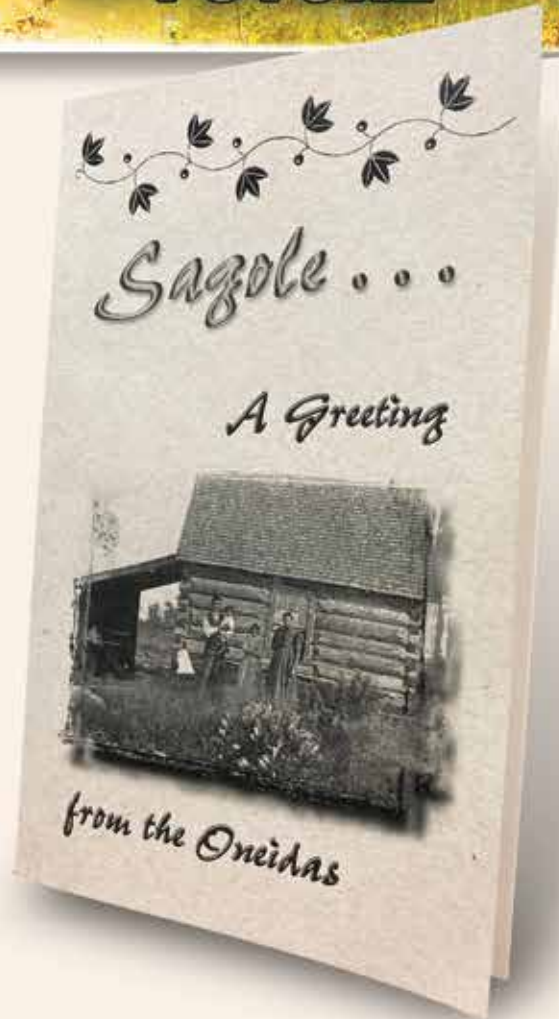

However, a few of the pictures that were published in the Kalihwisaks were identified by family members – in one case by great grandchildren.

This is our first attempt at publishing a work of this kind, and so it is the first edition. If any Oneida members have additional information regarding anything about this booklet, such updates can be added to subsequent editions.

This is a “fun” project because the work required encourages us to learn everything possible about the lives of our ancestors four generations before us. Their trials and triumphs and survival skills are incredible and amazing. Learning about them causes us to contemplate them and develop a deep appreciation for all they accomplished. Because they endured, we are here.

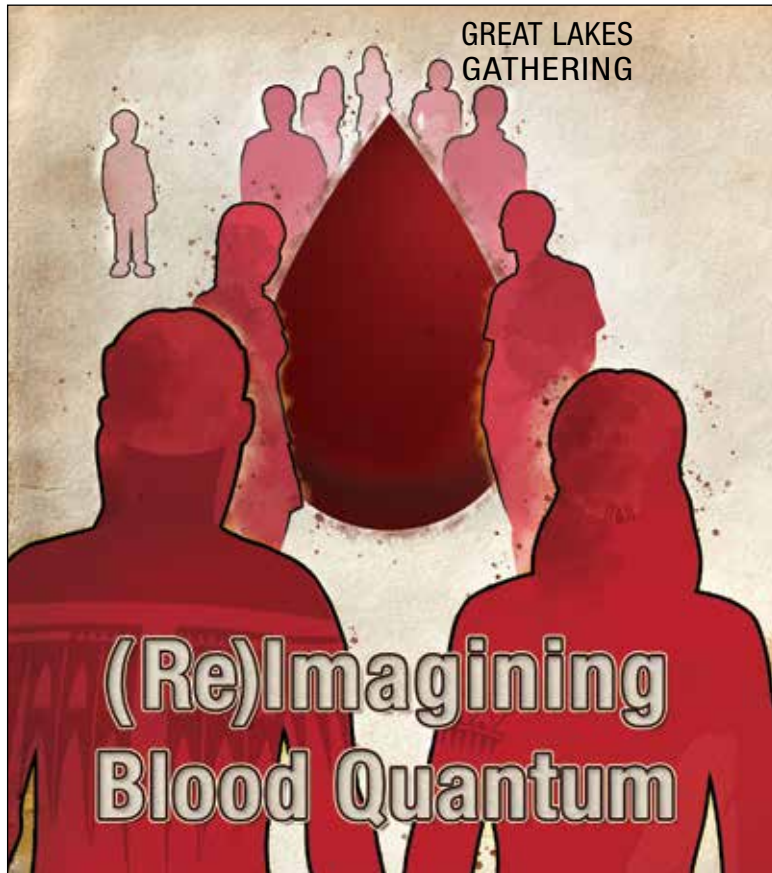



# SEVERE WEATHER AWARENESS



## LIGHTNING SAFETY

According to the National Weather Lightning Safety Council, 11 people were killed by lightning in the United States in 2021. Across the country, an average of 207 lightning injuries occur in a single year.

Even if the sky directly overhead may be clear, lightning can strike from 10 miles away, so if you hear thunder you are in danger. The safest place to seek shelter is inside a sturdy, enclosed structure, such as a house.

- Never shelter under an isolated tree. Lightning tends to strike taller objects first.
- Immediately get off elevated areas, such as hills, mountain ridges or peaks.
- Immediately get out of and away from water.
- Stay away from objects that conduct electricity.
- Never lie flat on the ground.

If someone is struck by lightning, they may need immediate medical attention. Lightning victims do not carry an electrical charge and thus, are safe to touch. Call 9-1-1 and monitor the victim. Start CPR or, if needed, use an automated external defibrillator.



## TORNADO DO'S & DONT'S

### DO

- Make sure you have a portable radio, preferably a NOAA Weather Radio, for weather alerts and updates.
- Seek shelter in the lowest level of your home, such as basement or storm cellar. If you don't have a basement, go to an inner hallway, a smaller inner room, or a closet.
- Keep away from all windows and glass doorways.
- Stay inside until you're certain the storm has passed, as multiple tornadoes can emerge from the same storm.

### DON'T

- Do not use elevators because the power may fail, leaving you trapped.
- Do not completely cover yourself with a mattress.
- Don't waste time moving mattresses around.
- Do not leave a building to attempt to "escape" a tornado.
- Do not remain in a mobile home during a tornado. Even mobile homes equipped with tie-down systems cannot withstand the force of a tornado's winds.

Kathleen “Linky” Elm, 82, Oneida, passed away at home surrounded by family on June 27, 2022. The daughter of Vernon and Katherine

(Metoxen) Jourdan was born on June 19, 1940.

Linky went to Chicago Corners School, a two-room schoolhouse in De Pere. She graduated from Seymour High School and spent many years as a Nurse’s Aide in Oneida.

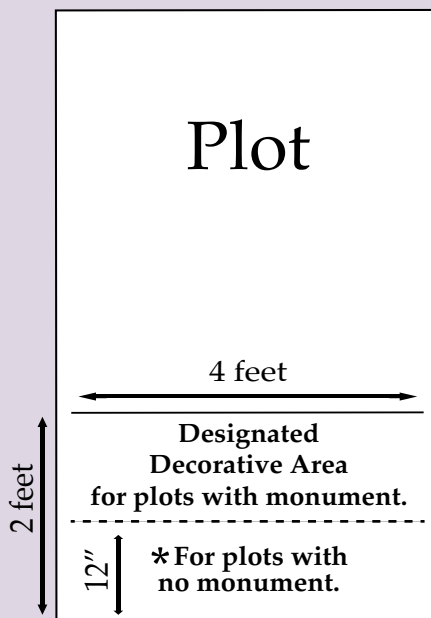
