

# Photo Helpful Hints

### How to submit photos for printing

The digital images you are seeing daily are usually somewhere between 72 and 100 DPI. The images you see when you get film developed or open a picture book are 300 DPI or higher. This is because a printed image requires much more detail per inch to showcase clarity. High Res means High Resolution. Basically, resolution is the density of the pixels in a digital image. The more pixels, the higher the definition of the photo.



Downloaded from a website or Google: Images found on the internet are generally a lower 72-100 dpi to help speed up load time. Do not use Screen shot from any phones, this quality will not work for print. Do not use.

Emailed Photo: Sometimes when you email a photo without ensuring a lossless compression, the email will default to an optimized size. This is actually compressing the size of your image.

- Saved from Instagram: Instagram's image dimensions are a maximum of 1080 pixels wide at 72 DPI. This would translate to a 3.6 inch wide image at 300 dpi. So if your image is larger than 3.6 inches for your project, then it will be low-resolution, pixelated (72 DPI is how the image will be). **Do not use.**
- Saved from a Word Document: If an image is saved and sent to you in a word document and then copy & pasted into your project file, then it will always be pixelated (72 DPI is how the image will be). **Do not use.**

How to Email Photos – Attaching the file is the only correct way to send art to a print shop. By attaching the file it keeps the art in its original format and resolution. GOOD

• By dropping an image inside the email: software will reconfigure it to its own specifications and change the format, resolution and even change the color profile from CMYK to RGB. **Do not use.** 

### Bigger is better!

For printed publications, always use the highest resolution (biggest) original file possible. KB is smaller, much smaller, than a MegaByte or MB. You can tell higher resolution images by their bigger file sizes. Any image file less than 1MB will probably not be much use for high quality printing (unless it's going to be very tiny). Don't try to scale or touch up a Low Resoultion photo. Send it to your designer for evaluation and they'll be able to tell you if it's usable. Photo taken on SmartPhone are roughly 12MB. Test a photo from your phone by emailing yourself a photo.

### Common file sizes for jpgs:

- A small head shot (1.5" x 1.75") needs to be at least 450 x 525 pixels, which is around 900 KB If your file size is less than about 850K, it may not be big enough.
- A (1/4 page 3.75" x 4.6875") needs to be at least 1125 x 1397 pixels which is around 6MB. If your file size is less than 4MB, it may not be big enough.
- A (1/2 page 7.75" x 4.6875") needs to be at least 1125 x 1397 pixels which is around 12MB. If your file size is less than 6MB, it may not be big enough.
- A full page (7.75"×9.625") needs to be at least 2888 x 2325 pixels which is around 25MB. If your file size is less than 10 MB, it may not be big enough.

### Final Tip:

Don't take low resolution photos! You can easily downsize images for the web, but you can never upsize a photo if you want to use it in print.

Canva is a free-to-use online graphic design tool. - https://www.canva.com/

Using the free version of Canva, select any free template that is 8.5" x11" or create your own flyer. You will not be able to resize the template to specific ad size unless you *purchase the subscription*.

The workaround is to use the guide on the document to mark the art area - This is for free templates only.

For a full page ad (7.75" x 9.625") from a 8.5" x 11" page template. You will use the guides to mark the art area 7.75" x 9.625"

#### How to find guide position using 8.5" x 11" template

The width of the template is 8.5" minus 7.75" (the ad width size), divide by 2.

Width 8.5" - 7.75" = .75" .75" / 2 = .375" Left and right guides are .375" from edge.

Do the same with the height

Template is 11" in height minus ad height is 9.625" divide by 2.


Height 11" - 9.625" = 1.375" | 1.375" | 2 = .6875" Top and bottom guides are .6875" from edge.


- **1** File ▶ Show Ruler and Guides.





Abuse, domestic violence, maltreatment, and neglect do not discriminate by age, race, economic status or community. The short- and long-term effects can impact victims in often unforeseen ways and it differs from person to person. However, one thing is certain: the effects of child abuse and neglect can last a lifetime.

It's important to understand that child abuse can take many forms. The obvious, of course, is the intentional harm or mistreatment of a person under the age of 18. But it also includes verbal assault or emotional injury to self-esteem.

Neglect is also a form of abuse by depriving a child of their basic needs and failure to give proper care. This includes inadequate supervision, health care, food, clothing, housing, education, affection and safety needs.

Unfortunately, abuse can be difficult to detect. And the causes of child abuse aren't simple either, with many contributing factors that can range from poverty to alcohol and drug abuse to mental health issues.

One thing is for certain: The effects of child abuse and neglect can be devastating. Children may feel alone or isolated, fearful, or distrustful of others. There may be lifelong psychological consequences such as depression, low •

For forty years the Oneida Cannery, located at Norbert Hill Center, has been a critical component of the Oneida Community. On August 25th, 2021, the Oneida Business Committee voted to obligate \$7.2 million dollars

to create a state-of-the-art Food Innovation Center.

"The cannery was turning away an estimated 400 customers per year for its basic value-add corn and dehydrated products and another 40 participants per year for classes. In its current state,

the cannery can no longer execute its mission efficiently or safely." Say Jamie Betters, Cannery coordinator.

Because of the facilities advancing age, limited capacity, multiple building and equipment repairs, design and construction for a new building was prioritized. More than a decade of diligent research and planning has gone into the design of the new Food Innovation Center, with careful consideration for the indigenous food production and the educational opportunities for community members and businesses.

The expanded design, just under 12,000 sq ft, will surpass the current limited space at the old facility will support Oneida's food security and sovereignty initiatives. The new facility will also feature an on-site retail outlet where ready-to-eat items, dehydrated, freeze-dried produce, fresh-pressed juices and breads will be available for purchase. A shared rental kitchen will be available to Oneida members to explore their entrepreneurial interest in food and beverage. There will also be two state-of-the-art demonstration kitchens that will allow double the food-related programming.

Abuse, domestic violence, maltreatment, and neglect do not discriminate by age, race, economic status or community. The short- and long-term effects can impact victims in often unforeseen ways and it differs from person to person. However, one thing is certain: the effects of child abuse and neglect can last a lifetime.

It's important to understand that child abuse can take many forms. The obvious, of course, is the intentional harm or mistreatment of a person under the age of 18. But it also includes

verbal assault or emotional injury to self-esteem.

Neglect is also a form of abuse by depriving a child of their basic needs and failure to give proper care. This includes inadequate supervision, health care, food, clothing, housing, education, affection and safety needs.

Unfortunately, abuse can be difficult to detect. And the causes of child abuse aren't simple either, with many contributing factors that can range from poverty to alcohol and drug abuse to mental health issues.

One thing is for certain: The effects of child abuse and neglect can be devastating. Children may feel alone or isolated, fearful, or distrustful of others. There may be lifelong psychological consequences such as depression, low self-esteem, difficulty building relationships or educational challenges.

However, there is hope for helping children in abusive situations. Research shows children who receive support in early childhood can prevent or even reverse the damaging effects of early life stress.

This is where all of us have a role to play:

• If you think a child you know may

be neglected, try talking to the parent or guardian to see what stresses they may be under and determine how you can help or if you can direct them to services that could help. Then follow up with them so they know you care. If the neglect is significant, call 911.

- Be a positive influence on the children in your life. Whether it's your own child, a neighborhood child, or a niece or nephew, be kind and encouraging.
- If you witness child abuse firsthand, call 911. While you may hesitate because you don't want to get involved, always keep the child foremost in your mind.
- Check in with parents in your family or community. They may need someone to talk with, or an hour or two break, which could make a difference in how they treat their child.
- Donate to local organizations that provide basic needs and care for those who have been abused or neglected.

Our collective effort to prevent child abuse is a step in the right direction. Hope, education and community resources are powerful tools for change.
