Next Tribal Coordinating Committee (TCC) meeting is December 6th at 3 PM.

COIPP grant Monthly Events –TAP will be hosting two monthly events for community members. One event for adults and another for children.

September 2022 - National Recovery Month

- Social media campaign of Oneida's Faces of Recovery promoted weekly.
- Community Smudge Walk September 14th
- Collaborated with Oneida Behavioral Health to assist with the Recovery Nest Grand Opening on September 22nd.
- Narcan Training and Distribution September 16th and 30th at OneStop
 - o Completed Narcan Training with Transit staff on September 22nd
- Completed our TAP Survey at the Farmers Market on September 15th with 204 responses.

October 2022

- Community Smudge Walk October 13th cancelled due to weather
- Community Clean Up October 26th in Cornelius Circle
- Narcan Training and Distribution October 14th and 28th at OneStop
- 2 Moccasin making classes for 25 community members. TAP provided materials for moccasins as well as a harm reduction education.

Smudge walks – We had our Smudge walk on September 14th with 8 community members that walked through Site 2, Tall Feather, and Cornelius Circle. October's and November's Smudge Walk was cancelled due to weather. Community Smudge Walks will continue in April.

Community Clean up –We had a community clean up on October 26th in Cornelius Circle. 3 adult and 12 youth community members volunteered. Community Clean Ups will continue in April.

Quarterly Newsletter - TAP's Quarterly newsletter will be sent out in December 2022.

Narcan Training and Distribution – TAP team has trained and distributed 75 Narcan Kits (with 2 doses in each kit) since August 2022. In collaboration with OneStop retail, we will continue to do Narcan Training and Distribution twice a month at various locations.

Education about ceremonies will began 11/22/22 in collaboration with Cultural Heritage and Oneida Comprehensive Housing.

Subcommittee meetings have been postponed until we are fully staffed.
