

Harm Reduction Awareness. Bi-monthly, we are providing Narcan Training and Distribution as a collaborative effort with OneStop Retail. TAP is available to facilitate group trainings, upon request.

Culture is Prevention. TAP in collaboration with Oneida Cultural Heritage and Oneida Comprehensive Housing are providing an overview, in English, of the ceremonies to encourage more community members to the Longhouse. The next planning meeting to provide on Maple Ceremony is March 15<sup>th</sup> at 5:30 PM at the Longhouse. TAP will continue to collaborate with these departments to provide ceremony education to the Oneida community.

TAP's upcoming *Tetwatatehsnye'* Conference is scheduled on March 29<sup>th</sup> at the Radisson. *Tetwatatehsnye'* means "we all take care of each other." Keynote speakers include Tatanka Means and Lenny Hayes. Agenda and registration for the event is available. 136 people have registered. Contact TAP for more information.
