ORDER GRANTING PLAINTIFF'S MOTION TO DISMISS

This case came before the Oneida Trial Court, Honorable Layatalati Hill presiding.

BACKGROUND

At a citation pre-trial hearing on May 16, 2024, Defendant appeared in-person to enter a plea to contest a citation issued to him for the alleged violation of Oneida Code of Laws (O.C.L.), 309.9-8, Possession of Prohibited Drugs – 1st offense, resulting in a \$250.00 fine plus \$25.00 court costs. The citation required a mandatory appearance. The Court accepted Defendant's plea to contest the citation and scheduled the case for a trial on July 16, 2024, at 11:00 a.m. On July 11, 2024, Plaintiff's representative, Attorney Kelly McAndrews, filed a Motion to Dismiss.

FINDING OF FACTS

- 1. The Court has subject matter and personal jurisdiction over this matter.
- 2. All entitled to notice of the citation pre-trial hearing received notice.
- 3. Defendant appeared in-person at the citation pre-trial hearing on May 16, 2024. Defendant was accompanied by his mother, Ms. Lisa Hill.
- 4. Defendant is represented by Atty. Christopher T. Froelich, attorney at law.
 - a. On May 16, 2024, Atty. Froelich filed a letter with the Trial Court with notice that he is unable to appear in-person at the May 16, 2024, citation pre-trial hearing.
 - b. On May 7, 2024, Atty. Froelich filed a notice of representation with the Trial Court.
- 5. Defendant was personally served the citation by Oneida Police Department (O.P.D.) officer,

- E. Metoxen. The date of service was not provided to the Court.
- 6. Defendant was issued a citation for the alleged violation of O.C.L. 309.9-8, Possession of Prohibited Drugs 1st offense, resulting in a \$250.00 fine plus \$25.00 court costs.
 - a. The citation was issued in response to an incident on January 9, 2024, at the Oneida Nation Elementary School.
- 7. At the hearing, Defendant acknowledged his rights and entered a plea to contest the citation.
- 8. After the hearing, the parties agreed to a trial date on July 16, 2024, at 11:00 a.m.
- 9. On July 11, 2024, Plaintiff filed a Motion to Dismiss.

PRINCIPLES OF LAW

Oneida Code of Laws Title 3. Health & Public Safety - Chapter 309 Public Peace

309.9-8. *Possession of Prohibited Drugs.* A person commits the civil infraction of possession of prohibited drugs if he or she possesses or consumes a prohibited drug or is in possession of any drug paraphernalia.

Oneida Code of Laws Title 8. Judiciary - Chapter 803 Oneida Judiciary Rules of Civil Procedure

803.7-4. *Form of Motion*. A request for a Court order shall be made by motion. The motion shall:

- (a) Be in writing unless made during a hearing or trial;
- (b) State with particularity the grounds for seeking the order; and
- (c) State the relief sought.

ANALYSIS

On July 11, 2024, Plaintiff filed a Motion to Dismiss stating they do not intend to further prosecute this matter because Defendant is no longer employed as a custodian with the Nation and any concerns that he may have placed at the elementary school are alleviated. The Court finds the request reasonable and grants the motion.

ORDER

- 1. Plaintiff's Motion to Dismiss is **GRANTED**.
- 2. This case is dismissed, with prejudice.

3. If Respondent opposes the dismissal of this case, he may file a motion stating as such within fourteen (14) days of the signing of this Order.

IT IS SO ORDERED.
