BC Resolution # 03-26-25-I Labor Allocation Modification - Transfer of Position from Environmental, Land, and Agriculture Division to Law Office - Paralegal

- **WHEREAS,** the Oneida Nation is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America; and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Nation; and
- **WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1, of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- **WHEREAS,** the Fiscal Year 2025 budget contains a position within the Environmental, Land, and Agricultural Division for processing probate actions, the Land, Title, and Trust Specialist; and
- WHEREAS, the Division and the Oneida Law Office have identified that a paralegal position within the Oneida Law Office addressing probate matters would result in additional technical supervision and help to address the backlog; and
- WHEREAS, Section 121.9-3¹ of the Budget and Finances Law allows for unbudgeted positions to be approved; and
- **WHEREAS,** the Oneida Business Committee has adopted the *Employment Cap and Labor Allocations Level Standard Operating Procedure* for guidance on this matter which allows for changes to address organizational needs, section 8.2.1, or to allow programs and services to operate in a more efficient or effective manner, section 8.2.2²; and

- 1. approves the reduction of one position (Land, Title and Trust Specialist) from the Environmental, Land and Agriculture Division; and
- 2. approves the increase in one position (Paralegal) in the Oneida Law Office.
