BC Resolution # 04-14-25-B Use of Wisconsin Tribal Assistance Grant Funds

WHEREAS,	the Oneida Nation is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America; and
WHEREAS,	the Oneida General Tribal Council is the governing body of the Oneida Nation; and
WHEREAS,	the Oneida Business Committee has been delegated the authority of Article IV, Section 1, of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
WHEREAS,	in 2023 the Oneida Nation received \$1,000,000 from the State of Wisconsin as a Tribal Assistance Grant; and
WHEREAS,	per the terms and conditions, "The Nation may use the Grant Award funds as the Nation deems necessary, except that no Grant Award funds may be used to pay for gaming-related expenses."; and
WHEREAS,	the Oneida Business Committee provided guidance to use the funds for the purpose of strengthening the Oneida Nation community, as well as strengthening relationships with neighboring communities; and
WHEREAS,	the Oneida Business Committee reviewed proposed uses during the Thursday, April 3, 2025 BC Work Session; and

NOW THEREFORE BE IT RESOLVED, the Oneida Business Committee approves the use of the Tribal Assistance Grant as identified below.

- Project Owner: Mark W. Powless, General Manager
- Oneida Reads to hire two staff to provide summer early literacy supports utilizing \$50,000.
- Oneida Nation School System to implement track and field upgrades utilizing \$150,000.
- A donation to Great Lakes Inter-Tribal Council for the Adolescent Recovery and Wellness Center utilizing \$30,000.
- A donation to the City of Green Bay for the Ted Fritsch Park water feature utilizing \$100,000.
- Oneida Tourism to fund Oneida Nation upgrades in preparation for the NFL Draft, utilizing \$120,000.
- Oneida Intergovernmental Affairs to fund the installation of Oneida welcome signs utilizing \$150,000.
- Oneida Tourism to fund the 2025 Oneida Pow Wow utilizing \$150,000.
- Bay Beach Shoreline Improvements Project utilizing \$100,000.
- Family Resource Center donation utilizing \$100,000.
