Obligation for CIP #22-115 Public Market Utilizing Tribal Contribution Savings

- WHEREAS,** the Oneida Nation is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Nation; and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1, of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS,** the Oneida Nation has received Fiscal Recovery Funds (FRF) through the American Rescue Plan Act of 2021 (ARPA) funds to address matters arising out of the COVID-19 pandemic; and
- WHEREAS,** the Oneida Business Committee has approved application of ARPA FRF through the revenue loss formula set forth in 31 CFR 35.6(d)(2) which applied these federal funds throughout the Nation's budget to governmental programs business units beginning with "42#####"; and
- WHEREAS,** the savings from the application of these funds has resulted in tribal funds being placed in the line "Tribal Contribution Savings" in the Investment Report presented in the Treasurer's Report; and
- WHEREAS,** this request is to fund Phase I - Farmer's Market Shade Structures which will create a permanent recognizable location and will provide covered space for vendors, supporting the market's economic and environmental sustainability; and
- WHEREAS,** the Project Owner for the proposed project is requesting \$574,000 obligated from the Tribal Contribution Savings; and
- WHEREAS,** this project will be concluded by December 31, 2027; and
- WHEREAS,** the Oneida Business Committee has reviewed the proposed project; and

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee approves the obligation of funds for the Oneida Public Market (CIP #22-115) in the amount of \$574,000 from Tribal Contribution Savings; with Paul J. Witek, Engineering Director/Senior Architect assigned as the Project Owner.
