

On-Line Electronic and Hazardous Waste Voucher Service Available to Oneida Membership

The Oneida Environmental, Health, Safety, Land and Agriculture Division and Oneida Utilities Department, is pleased to announce the resumption of the voucher program for electronic and hazardous waste disposal at the Brown County Hazardous Material Facility.

It is available through the Oneida Nation's Members Only website at <https://oneida-nsn.gov/member-login/>. Once logged in go to Oneida Online Services and follow the prompts. The tabs provide additional information about acceptable items, hours, disposal facility location and voucher application. Vouchers are limited to one per member per month.

Once the voucher form is completed, the applicant will receive an email and the Hazardous Material Facility will receive a notification. When you go the facility you give them your name and, if asked, present your Tribal ID. No need to have a printed copy of the voucher.
