Nominations will be conducted for the vacancies listed. Any person nominated at the Caucus **must** be present to accept/decline the nomination. All other individuals may petition to have their name placed on the 2026 General Election Ballot.

- Individuals nominated will need to complete a separate application for each position they were nominated for.
- Individuals petitioning to have their name placed on the on ballot will need to complete a separate application and petition for each position they are vying for.

Applications will be available at the Caucus or may be picked up at the Government Administrative Office located at the Norbert Hill Center N7210 Seminary Rd Oneida, WI. 54155. The deadline for submitting applications, petitions and other supporting documents must be brought into the Government Administrative Office is:

FRIDAY – APRIL 17, 2026. BY 4:30 P.M.

****NOTE:** Applicants must provide the appropriate documentation, including but not limited to, copies of degree, official transcripts, and certifications as proof of qualification for the position in which they seek where applicable. Those applications that do not have the proper back-up documentation regarding qualifications will be deemed as incomplete and applicant will not be eligible for candidacy.

Candidates for election to office found in violation of governing documents may be disqualified from taking office. These governing documents include but are not limited to the: Constitution of the Oneida Nation; Election Law; Judiciary Law; Oneida Nation Gaming Ordinance; Boards, Committees, & Commissions Law; and applicable bylaws.
