

Oneida Lake Rustic Camping Ground Rules and Regulations

RESERVATIONS: Available in person at Conservation & Land Management Office 470 Airport Dr.

Campsites may be occupied by a parent, parents, or legal guardian (18 years old or older) with their dependent children and not more than two (2) visitors/guests. The total number of Campers may NOT exceed more than ten (10) persons, regardless of age, in any established campsite. Groups of more than ten (10) campers will need to reserve additional campsites. Sites are limited to stays of no than five (5) consecutive days.

- \$15.00 Daily Camp Site Rate; During Prime Season (Non-refundable) (May 1 – September 30)
- \$3.00 Parking Pass Rate; For Two (2) Vehicles (per reservation) (**NO** ATV or UTV Vehicles)
- \$3.00 Reservation Cancellation Fee
- \$75.00 Deposit Fee Per reservation separate payment, Check or Money Order, Returnable after check-out.

All guests, family members, and visitors are responsible for abiding by **ANY/ALL** rules, laws, and policies.

Visitors **MUST** Park in designated overflow parking area and walk to access the site they are visiting.

Anyone failing to adhere to the established rules, laws, and policies may be evicted/removed from the campsite/property, at the discretion of the Conservation LEAF Division Staff, or Designee. Any violation

WILL RESULT in the loss of deposit refund option and payment of any/all assessment fee(s) for damage or repairs, for the registered Camper. **Review and initial each section and sign at the bottom**

Cancellations:

1. May be made by calling (920) 869-6500. After regular business hours, please leave a message.
2. You may cancel, no later than 3:00p.m., three (3) days prior to the day of the reservation. You will be issued a full refund of camping fees, minus a \$3.00 cancellation fee.
3. Late cancellations will result in refunded camping fees, minus the cost of one (1) night.
4. No refunds will be issued due to weather.

Check In/Out

1. Campsite check-in is 3:00p.m. and check-out is 9:00a.m.
2. A maximum of three (3) tents are allowed on sites and must be located within the defined boundaries.
3. Campers should proceed to their reserved campsite after the 3:00p.m. check in time. Campers will be automatically checked in through the online reservation system.
4. Staff may periodically visit campsites to verify check-in. Campers should keep a copy of their reservation on hand or available on their mobile device, for staff to verify the reservation.
5. Information regarding how to get in touch with Security or Conservation LEAF Division Staff, or Designee will be available, at Kiosks located near the campgrounds.
6. NO more than five (5) consecutive days, of camping, is allowed.

Vehicle Parking/Visitors

1. Motor vehicles are restricted to the designated parking area on each campsite. No more than two (2) motor vehicles (except as many as six motorcycles) per campsite.
2. ALL VISITORS MUST utilize the Overflow parking location, adjacent to the campsites.
3. All guests, family members and visitors are responsible for abiding by **ANY/ALL** Oneida Rules, Laws, and Policies.

Camp Site Rules and Regulations

1. NO illegal drugs, alcoholic beverages or glass bottles allowed on grounds.
2. NO recreation trailer, pickup truck camper, or motor home may occupy a campsite.
3. NO ATV/UTV vehicles.
4. NO fireworks or explosive materials.
5. The camp sites are closed to non-campers/visitors between 10:00 p.m. and 8:00 a.m.
6. All non-campers/visitors must leave the park by 10:00 p.m. During closed hours campers must be in/at their registered campsite.
7. No camping party may set up or take down a tent(s) between 10:00 p.m. and 8:00 a.m.
8. Please be courteous to your camping neighbors. At NO time may the noise on a campsite create a disturbance or interfere in any manner with other people's enjoyment of the park. (**Quit Time Between 10:00 p.m. and 8:00 a.m.**)
9. Pets are limited to cats and dogs.
10. Pets must always be under owner's control.
11. Pets must be leashed and kept on a leash not exceeding 6 feet.
12. Pets are NOT allowed in buildings, beaches, playgrounds, and picnic areas.
13. Pets are NOT to be left tied up or unattended.
14. Pet Owner's shall collect pet waste and dispose of properly, offsite.
15. Hanging clotheslines and/or clothes outside of tent(s) is prohibited.
16. Posted signs/regulations/laws must be adhered to. Registered campers are responsible for the conduct, behavior, and control of your camping party and visiting guests.
17. Registered camper(s) are **FINANCIALLY** responsible for any/all damage to campsite grounds/property, intentional or accidental.
18. Damage or defacing of campsite grounds/property/signage, equipment **WILL** result in immediate eviction, loss of deposit, payment of assessment fee(s), and/or possible prosecution.
19. Oneida Nation staff reserves the right to deny the camping/access/parking of any vehicle by guests whose vehicle is deemed unsafe, excessively noisy, or visually distracting.
20. Oneida Nation and Conservation LEAF Division Staff, or Designee are **NOT** responsible for loss of damage of property due to negligence, accident, vandalism, theft, or acts of nature.
21. All guests, family members, and visitors are responsible for abiding by **ANY/ALL** rules, laws, policies.

22. Any person failing to adhere to the established policies may be evicted/removed from the campsite/property, at the sole discretion of the Conservation LEAF Division Staff, or Designee. Violations will result in loss of deposit, for the registered camper.
23. Removal/Eviction will result in loss of deposit and camping fees.

Trash

1. Leave no trace policy **“Pack It In...Pack It Out” You are responsible for removing your trash/recycling with you when you vacate the camp area.**
2. Plan your camping to produce as little trash/recycling as possible. Campsites, buildings, and picnic areas **DO NOT** have trash/recycle cans.
3. If using your own grill, place coals in an available fire ring or at a designated coal disposal site.
4. Pick up garbage and recyclables from your site daily to discourage nighttime visits from animals.
5. Do not feed wild animals; feeding conditions them to expect food and causes future problems.

Firewood

1. Firewood is not provided, please monitor/recognize burn advisory warnings or bans.
2. Firewood must be collected/obtained offsite of the camping locations.
 - a. Firewood is considered natural wood resources – NOT manufactured pallets, tables, furniture, etc.
3. Campers are reminded to utilize certified firewood that has been properly treated or aged to kill any infesting pests or diseases to protect Oneida Nation trees.
4. Fires are allowed in fire rings and grills **ONLY**.
5. Do not leave fires unattended and put out all fires before leaving.
6. Do not burn garbage, plastic, cans, or other recyclable items.
7. Watch wind direction to ensure sparks are not getting on flammable materials and put the fire out if wind changes begin to cause concern.
8. Do not remove hot materials from the fire ring or grill and make sure the fire is out and the grill or fire ring are cool before leaving the area.
